**RESOLUTIONS ON FIRST READING**

**House Concurrent Resolution 28**

Representative Bacon introduced House Concurrent Resolution 28:

A CONCURRENT RESOLUTION honoring the South Spencer High School Lady Rebels softball team.

*Whereas, The South Spencer High School softball team brought home the school's first state title for any girls sports program by defeating Southmont High School by a score of 1-0 in the Class 2A state softball championship;*

*Whereas, This year, however, was not the school's first appearance in the championship game; the Lady Rebels appeared in the final game in 1999 but fell short;*

*Whereas, The game remained scoreless for six and a half innings when senior Chandra Schroeder led off the bottom of the seventh with a double to left center;*

*Whereas, Freshman Hannah Epperson delivered the game winning hit to centerfield, driving in Chandra Schroeder;*

*Whereas, Junior Kaylea Horn threw a two-hitter and struck out 11 batters;*

*Whereas, The Lady Rebels hold a very special place in the heart of coach Tara Compton, who was a member of the first softball team at South Spencer High School in 1988 and has coached the team for the past 17 years;*

*Whereas, Chandra Schroeder was chosen as the Mental Attitude Award recipient in Class 2A softball by the members of the Indiana High School Athletic Association Executive Committee;*

*Whereas, A talented multisport athlete, Chandra, a three-year starter, has played shortstop, first base, and outfield and has three years of varsity experience in basketball; she also earned Pocket Athletic Conference honors for her achievements in golf; and*

*Whereas, Outstanding accomplishments, whether they be in the classroom or on the athletic field, deserve special recognition: Therefore,*

*Be it resolved by the House of Representatives of the General Assembly of the State of Indiana, the Senate concurring:*

SECTION 1. That the Indiana General Assembly congratulates the South Spencer High School Lady Rebels softball team on its Class 2A state championship and wishes the girls continued success in all their future endeavors.

SECTION 2. **House Resolution 20**

Representative McNamara introduced House Resolution 20:

A HOUSE RESOLUTION recognizing the West Side Nut Club.

*Whereas, Founded on March 16, 1921, the West Side Nut Club is one of Evansville's most civic minded groups;*

*Whereas, This unique organization began when a small group of businessmen and merchants from the west side of Evansville decided to form an organization to proclaim the interests of the west side;*

*Whereas, The founders elected officers, decided upon a specific time and place to meet, and established a set of aims and principles for the organization;*

*Whereas, The organization prospered and grew to its current 300 member roster whose main event each year is the Fall Festival, a weeklong gala with free entertainment, carnival attractions, over 126 food booths, amateur talent competitions, and a huge parade that is considered to be one of the largest street festivals in the country;*

*Whereas, The estimated attendance for the Fall Festival is close to 250,000, and the proceeds afford the club an opportunity to donate to the community throughout the rest of the year;*

*Whereas, The yearly average donation of the West Side Nut Club to the community is between \$200,000 and \$225,000;*

*Whereas, The group estimates that it has donated approximately \$5,000,000 since the club's founding;*

*Whereas, Since the group's main focus is on the youth of the area, the larger donations go to schools in the area, but the*

*club also makes contributions to many organizations, including the Evansville Department of Parks and Recreation, Howell Booster Club, Ozanam Family Shelter, Dream Center, Evansville police and fire departments, American Red Cross, and Albion Fellows Bacon Center;*

*Whereas, In addition to donations to education, the West Side Nut Club also supports such organizations as Wish Upon A Star, Easter Seals, and MDA;*

*Whereas, Although the origin of the name West Side Nut Club is unknown, perhaps the members considered themselves to be the acorns from which the future "mighty oaks" would grow; and*

*Whereas, The West Side Nut Club has dedicated itself to helping those in need in the community and continues to work toward this admirable goal: Therefore,*

*Be it resolved by the House of Representatives of the General Assembly of the State of Indiana:*

SECTION 1. That the Indiana House of Representatives acknowledges the many contributions of the West Side Nut Club to those in need and urges the members to continue working to improve the lives of those around them.

SECTION 2. That the Principal Clerk of the House of Representatives transmit copies of this resolution to the West Side Nut Club.

*Whereas, On November 8, 2014, the Wes-Del High School volleyball team defeated the Christian Academy of Indiana 3-0 in the 2014 IHSAA Class A Volleyball Championship;*

*Whereas, This is the second IHSAA Class A championship title for the Wes-Del High School volleyball team, as the Warriors captured their first title in 2011;*

*Whereas, In the final match, Mariah Berry had 10 kills; Alysa Sutton had 10 kills and 4 aces; Megan Clark had 9 kills; Chloe Kinsey had 11 digs; and Kennedy Petro set the winning kill for fellow senior Mackenzie Whitehead;*

*Whereas, At the conclusion of the Class A finals, the IHSAA Executive Committee named Kristen Lansing as the recipient of the Class A Mental Attitude Award;*

*Whereas, Each year the IHSAA Executive Committee selects a senior player, nominated by her principal and coach, who was determined to have best demonstrated mental attitude, scholarship, leadership, and athletic ability; and*

*Whereas, It is fitting that special recognition is given to the young ladies and coaches of the Wes-Del High School volleyball team: Therefore,*

*Be it resolved by the Senate of the General Assembly of the State of Indiana, the House of Representatives concurring:*

SECTION 1. That the Indiana General Assembly congratulates the Wes-Del High School volleyball team on its second IHSAA Class A championship title.

#### **Senate Concurrent Resolution 18**

The Speaker handed down Senate Concurrent Resolution 18, sponsored by Representative Price:

A CONCURRENT RESOLUTION memorializing J.D. Richards for his many years of public service as a United States Marine, Indiana State Police Officer, Johnson County Sheriff, and exemplary employee of the Indiana Senate.

*Whereas, J.D. Richards, a resident of Franklin, Indiana, passed away at the age of seventy-five on January 11, 2015;*

*Whereas, Born on November 30, 1939, in Indianapolis, J.D. was the son of Andrew and Louise Richards;*

*Whereas, J.D. married his beloved wife, Wanda Richards, on March 22, 1963;*

*Whereas, A graduate of Union High School in Indianapolis, J.D. joined the United States Marine Reserves in 1957, and graduated from Franklin College in 1962;*

*Whereas, After graduating from Franklin, J.D. became active in the Marines and served in the Vietnam War, retiring as a Lieutenant Colonel after serving for thirty-seven years;*

*Whereas, After retiring from the Marines, J.D. taught at Center Grove and Franklin, and in the summers he worked for the Franklin Police Department;*

*Whereas, In 1970, J.D. attended the Indiana Police Academy and began his twenty-four year career in law enforcement with the Indiana State Police, retiring in 1995;*

*Whereas, J.D. ran for Sheriff of Johnson County in 1995 and after being elected he served two distinguished terms;*

*Whereas, After retiring as Johnson County Sheriff, J.D. became an employee of the Indiana Senate, working in the Office of Bill Distribution and Duplication; and*

*Whereas, J.D. was an exemplary Indiana Senate employee who was known by all for his friendly demeanor, and he greatly contributed to the spirit and decorum of the State House: Therefore,*

*Be it resolved by the Senate of the General Assembly of the State of Indiana, the House of Representatives concurring:*

SECTION 1. That the Indiana General Assembly memorializes J.D. Richards and his exemplary public service to his country and his community.

SECTION 2. The Secretary of the Senate is hereby directed to transmit copies of this Resolution to J.D.'s wife, Wanda Richards; his daughter Beth Houshour; his son Andrew Richards; his grandsons J.D. Houshour and Jon Houshour; and his brother Dale Richards.
