CERTIFICATION OF APPOINTMENT TO A VACANT STATE LEGISLATIVE OFFICE

TO THE HONORABLE DAVID LONG

WHEREAS, A vacancy occurred in the office of Indiana State Senate District 7, on January 2, 2018, due to the resignation of the Senator Brandt Hershman, who was elected to office as a candidate of the Indiana Republican Party;

WHEREAS, The duly elected and acting state chairman of the Indiana Republican Party set the place, date, and time of a caucus comprised of the eligible precinct committeemen from Indiana Senate District 7 and sent a notice by first class mail to all precinct committeemen in the caucus at least ten (10) days before the date of the meeting, setting forth the purpose, place, date and time of the meeting;

WHEREAS, The state chairman or his duly appointed designee presided over the aforesaid caucus, which was conducted on January 25, 2018;

WHEREAS, The caucus, voting by secret ballot, and a majority vote of those casting a vote for the candidate, selected an individual who resides within Indiana Senate District 7 to fill this vacancy;

WHEREAS, The individual selected to fill the aforesaid vacancy had filed a declaration of candidacy with the chairman of the caucus, and had previously filed a statement of economic interests under Indiana Code 2-2.1-3-2 with the Secretary of the Senate, at least seventy-two (72) hours before the time fixed for the caucus, all as required by Indiana Code 3-13-5-3;

WHEREAS, Under Indiana Code 3-13-5-6, the state chairman is required to certify the name of the individual selected under Indiana Code 3-13-5-1 to fill this vacancy to the President Pro Tempore of the Indiana Senate; and

WHEREAS, Under Indiana Code 3-13-5-6, the President Pro Tempore of the Indiana Senate is required to acknowledge receipt of this certification, submit a copy of the certificate to be included in the Journal of the Indiana Senate on the day when the individual is seated, (or if this certificate is received after the adjournment sine die of the General Assembly, on the first day that the Indiana Senate is in session following receipt of this certificate), and immediately forward the certificate to the Secretary of the State of Indiana;

A SENATE RESOLUTION honoring foster families for their support in serving and caring for Indiana's most vulnerable children.

Whereas, Foster Care provides a safe, nurturing, stable, and temporary environment for children who can no longer remain in their own homes due to the risk of abuse or neglect;

Whereas, Becoming a foster parent is considered one of the most challenging, yet rewarding opportunities an individual would experience in a lifetime, where individuals may act as mentors and peer models until a child can be reunited with their own family or a relative;

Whereas, In the 2017 fiscal year, nearly 26,000 Hoosier children suffering from abuse or neglect were cared for in a safe, nurturing foster home;

Whereas, More than 1,800 Hoosier children found a forever family when they were adopted by their foster parents in the 2017 fiscal year;

Whereas, At the end of 2017, 6,194 Hoosier families were serving Indiana's most vulnerable children by being licensed foster parents; and

Whereas, Foster Care offers a chance to make the world a better place, one child at a time: Therefore,

Senate Concurrent Resolution 24

Senate Concurrent Resolution 24, introduced by Senator Crider:

A CONCURRENT RESOLUTION congratulating the New Palestine High School girls softball team for winning the 2017 Indiana High School Athletic Association ("IHSAA") Class 3A state championship.

Whereas, New Palestine's softball team, the Dragons, finished the 2017 season with a twenty-two game win streak with a total of thirty-one wins and two losses;

Whereas, The Dragons prevailed against Herron, Indianapolis Bishop Chatard, Brebeuf Jesuit Preparatory,

Lebanon, Edgewood, and Evansville Memorial High School to play against Kankakee Valley High School in the state championship game located at Ben Davis High School;

Whereas, The Dragons set a state record of fifty-seven home runs in a season through thirty-three games including twenty-eight times where at least one ball left the yard during a single game;

Whereas, The Dragons obtained state records of 465 hits and 383 runs in a single season with an average of eleven runs per game, which included twenty-one home runs from junior Ashley Prange, who ended the season with a state record of 67 RBIs;

Whereas, Senior Elisha Barker pitched a complete game with four strikeouts for her twenty-second win of the year and was named the IHSAA's Class 3A Mental Attitude Award winner;

Whereas, New Palestine made thirteen runs in the championship game including a two run single by senior Abigail Davis in the second inning, eight runs on seven hits in the fourth inning including a score by freshman Michaela Jones on a throwing error, a three-run home run by Ashley Prange, a run through a sacrifice fly from sophomore Tatum Biddle, and run-scoring hits by senior Madison Whitaker and Elisha Barker, as well as one run in the fifth inning and two runs on the top of the seventh inning;

Whereas, Nine Dragons recorded at least one hit with five extra-base hits during the championship game including two doubles from senior Mary Crumlin, who tied a Class 3A championship record;

Whereas, The Dragons made numerous Class 3A state finals game records including seventeen hits, thirteen runs, and ten RBIs, while also tying a Class 3A record of seven hits during a single inning and issuing a combined Class 3A title game record of most combined hits and most combined runs with twenty-nine and nineteen respectively;

Whereas, This is the fourth championship for coach Ed Marcum who led the Dragons to titles in 2004 and 2008 and holds a record of 357-58 over his fourteen seasons at New Palestine; and

Whereas, New Palestine softball achieved its fourth state championship in school history with a final score of 13-6 against Kankakee Valley High School: Therefore,

Be it resolved by the Senate of the General Assembly of the State of Indiana, the House of Representatives concurring:

SECTION 1. That the Indiana General Assembly congratulates the New Palestine High School girls softball team,

the Dragons, for winning the 2017 Indiana High School Athletic Association ("IHSAA") Class 3A state championship title.

SECTION 2. Senate Concurrent Resolution 29

Senate Concurrent Resolution 29, introduced by Senator Head:

A CONCURRENT RESOLUTION congratulating the Pioneer Junior-Senior High School football team on winning the Indiana High School Athletic Association ("IHSAA") Class A state championship.

Whereas, The Pioneer Junior-Senior High School football team, the Panthers, completed the 2017 season with fifteen wins and zero losses;

Whereas, The Panthers competed against Carroll, North White, Lafayette Central Catholic, LaVille, and Monroe Central High Schools to play against Eastern Greene High School in the IHSAA Class A state championship game at Lucas Oil Stadium;

Whereas, Junior quarterback Jack Kiser completed two 2-yard rushing touchdowns in the first and second quarter to put the panthers ahead of Eastern Green 14-7;

Whereas, Sophomore running back Miles VonToble caught a 10-yard pass from Jack Kiser and fought a defender to the end zone for a touchdown with 1:50 left in the second quarter;

Whereas, Jack Kiser broke away from two defenders to throw an 18-yard touchdown pass to freshman running back Ezra Lewellen with 0:05 left in the second quarter to complete the first half of the championship game with a score of 28-7

Whereas, Jack Kiser broke through a hole in the line of scrimmage to sprint 53 yards for a rushing touchdown with 2:59 left in the third quarter;

Whereas, Junior fullback Daniel Gregorich broke through a

tight break in the line of scrimmage to run for a 30-yard touchdown with 3:33 left in the fourth quarter;

Whereas, Senior kicker Matthew Musbaum made all six extra point attempts during the championship game;

Whereas, The Panther defense completed 53 solo tackles, 26 assists, 5 tackles for a loss, and 3.5 sacks;

Whereas, The Panthers won the Class A championship game with a final score of 42-14 after scoring on six of their eight drives of the day;

Whereas, Senior offensive lineman Garrett Schroder was named the winner of the Blake Ress Mental Attitude Award for Class A for demonstrating the best mental attitude, scholarship, leadership, and athletic ability; and

Whereas, This is the third state championship game in the last four years, the second overall football state championship title, and the first championship title since 1997 for the Pioneer Junior-Senior High School football team: Therefore,

Be it resolved by the Senate of the General Assembly of the State of Indiana, the House of Representatives concurring:

SECTION 1. That the Indiana General Assembly congratulates the Pioneer Junior-Senior High School football team on winning the Indiana High School Athletic Association ("IHSAA") Class A state championship.

Whereas, Radio station WTLC-FM, founded by Dr. Frank Lloyd, launched in Indianapolis from the Dearborn Hotel in 1968;

Whereas, Alongside sister stations AM 1310 The Light, Hot 96.3, Radio NOW 100.9, BOOM 102.9, La Grande 105.1, and Telemundo Indy, WTLC-FM is owned and operated by Radio One;

Whereas, During its first 50 years, WTLC-FM has had great management and talent affiliated with the station including Jay Johnson, Al Hobbs, Russ Dodge, Gene Slaymaker, Amos Brown, Rickey Clark, Vicki Buchanan, Kelly Karson, Ray Cooper, Geno Shelton, Tony Lamont, Guy Black, Karen Vaughn, Amp Harris, Liz Dixson, and Jerry Wade to name a few;

Whereas, WTLC-FM is known as "Indy's R&B Leader" and uses an Urban Adult Contemporary format;

Whereas, WTLC-FM has been honored with numerous awards for broadcasting and journalistic excellence, including the Indianapolis Broadcasters Association Station of the Year in 2006, and the Billboard Magazine and Black Radio Exclusive Magazine Station of the Year Award;

Whereas, WTLC-FM has been honored with numerous awards for community and public service, including The Convoy of Hope, the Indianapolis Broadcasters Association 2017 Cardinal Awards for Black Santa, and our revitalization project of Wes Montgomery Park and other Indy parks;

Whereas, WTLC-FM has raised millions of dollars throughout the years for its community philanthropies such as the Mozel Sanders Thanksgiving Dinner, the United Negro College Fund, St. Jude Hospital, NAACP, Operation PUSH, and Martin University;

Whereas, WTLC-FM continues its legacy of entertainment, information, and service to Indianapolis in its 50th year of broadcasting; and

Whereas, WTLC-FM has accomplished many things during its first 50 years, and will accomplish much more in the coming 50 years: Therefore,

Be it resolved by the House of Representatives of the General Assembly of the State of Indiana, the Senate concurring:

SECTION 1. That the Indiana General Assembly recognizes WTLC's first 50 years of service to the community and the citizens of Indiana and wishes the station many more successful years.
