*Whereas, Nick Goepper grew up in Lawrenceburg in southeastern Indiana;*

*Whereas, Nick began skiing at a small resort called Perfect North Slopes when he was five years old;*

*Whereas, At age 13, Nick built his own park in his backyard with skate rails and a wooden kicker covered with Astroturf and watched endless ski movies at home;*

*Whereas, Encouraged by his parents, Nick began freeskiing at the pro-level in the winter of 2010-2011, qualifying in slopestyle for his first Dew Tour and Winter X Games in France;*

*Whereas, Nick continued to progress rapidly at the pro-level, placing second at Dew Tour stop number 1 and third at Dew Tour stop number 2 the next season;*

*Whereas, Nick won a silver medal at the 2012 Winter X Games in Aspen, then the gold medal at the 2013 Winter X Games slopestyle, and, finally, on December 21, 2013, Nick secured a spot on the Olympic team with his second-place finish at the United States Grand Prix slopestyle skiing contest at Copper Mountain;*

*Whereas, Nick worked hard to get to the Olympics, and his work was not just on the slopes of southern Indiana;*

*Whereas, Nick rang doorbells, handed out flyers that offered*

to do odd jobs for neighbors, and, on the school bus, took bulk boxes of candy bars and sold them to his friends to earn money to go to the Olympics;

Whereas, However, all this was a labor of love for Nick Goepper because from the moment Nick learned to "catch air" on his skis, he fell in love with the sport, and it has been his number one passion ever since; and

Whereas, Nick's determination and hard work paid off when he won the bronze medal at the Sochi Olympics in the slopestyle contest: Therefore,

Be it resolved by the House of Representatives of the General Assembly of the State of Indiana:

SECTION 1. That the Indiana House of Representatives congratulates Nick Goepper on his many accomplishments and expresses great pride in this outstanding Hoosier known throughout the world for his freeskiing.

### House Resolution 50

Representative Forestal introduced House Resolution 50:

A HOUSE RESOLUTION memorializing Andrew Jacobs, Jr.

Whereas, Former Indiana Congressman Andrew Jacobs, Jr. died peacefully at his home on Saturday, December 28, 2013 at the age of 81;

Whereas, Born in Indianapolis, Andy Jacobs graduated from Shortridge High School in 1949 and served as an infantryman in the United States Marine Corps during the Korean War;

Whereas, Andy Jacobs earned a bachelor's degree in business and a LL.B. from Indiana University;

Whereas, Andy Jacobs served his country and his state as a state legislator and Congressman serving in the United States House of Representatives for thirty years, with eight years of service on the Judiciary Committee and 22 years of service on the powerful Ways and Means Committee;

Whereas, Andy Jacobs was one of the early critics of the Vietnam War and coined the phrase "war wimp" to describe those who were eager to send others into combat, but who had avoided serving their country in the military;

Whereas, Andy Jacobs helped write the 1965 Voting Rights Act, cutting edge civil rights legislation, and worked closely throughout his career with civil rights leaders such as Reverend Andrew J. Brown;

Whereas, Andy Jacobs received numerous accolades and awards, including "The Drum Major for Justice", awarded to him by the Indiana Christian Leadership Conference (ICLC), which is the Indiana chapter of the Southern Christian Leadership Conference, founded by Dr. Martin Luther King Jr.;

Whereas, Andy Jacobs also authored a book on fellow congressman Adam Clayton Powell Jr. titled *The Powell Affair: Freedom Minus One*, that told the story of the 1967 vote in the United States House of Representatives which unseated Powell and excluded him from his formal political power;

Whereas, Andy Jacobs strongly believed that if a child's educational foundation was sound it not only benefitted the child, but society as a whole would be strengthened;

Whereas, the intense legislative efforts of Andy Jacobs toward cognitive preschool education for disadvantaged children were largely unheeded and are only now being acted upon;

Whereas, Known for being frugal, Andy Jacobs refused to accept pay raises between elections after 1969 and, in 1976 and every Congress thereafter, introduced the Payment Book Amendment to the Constitution that was designed to pay off the national debt and require the federal government to operate on a balanced budget;

Whereas, After retiring from the Congress, Andy Jacobs taught at IUPUI and became a columnist for NUVO Newsweekly; and

Whereas, Andrew Jacobs, Jr. was a selfless public servant, who never cared for the trappings of office but only the people he so ably represented: Therefore,

Be it resolved by the House of Representatives of the General Assembly of the State of Indiana:

SECTION 1. That the Indiana House of Representatives wishes to express its deepest sympathy to the family of Andrew Jacobs, Jr. and heartfelt gratitude for his years of dedicated service to Indiana and the entire world.

SECTION 2. That the Principal Clerk of the House of Representatives shall transmit copies of this resolution to his wife, Kim Hood Jacobs, and sons Andy and Steven Jacobs.

Whereas, Five years ago when George Gilbert took over the Tri-Central High School football program, the Trojans had finished 0-10;

Whereas, In the last 20 seasons, the Trojans had five winless seasons and six one-win campaigns;

Whereas, Through hard work and dedication, George Gilbert has taken the Trojans all the way to the Class A football state championship;

Whereas, George Gilbert arrived at Tri-Central from Clinton Central in 2009 due to the trust and confidence placed in him by Principal Dave Driggs and Athletic Director Gary Rhew;

Whereas, Seen as a great leader and principled man, George Gilbert was the perfect man to teach the young men of Tri-Central High School;

Whereas, In recognition of his outstanding accomplishment, George Gilbert was one of three national finalists for the Don Shula NFL High School Coach of the Year Award; and

Whereas, George Gilbert brought drive and determination back to the Tri-Central football program and has shown the youth of this school a pride in accomplishment and desire to succeed that is a great example for all young Hoosiers: Therefore,

Be it resolved by the House of Representatives of the General Assembly of the State of Indiana:

SECTION 1. That the Indiana House of Representatives recognizes the great accomplishments of George Gilbert.

SECTION 2. That the Principal Clerk of the House of Representatives shall transmit copies of this resolution to George Gilbert and Tri-Central High School principal Dave Driggs.

### House Concurrent Resolution 22

Representative Kubacki introduced House Concurrent Resolution 22:

A CONCURRENT RESOLUTION urging the Governor to designate March 30 each year as Welcome Home Vietnam Veterans Day.

*Whereas, More than 58,000 members of the United States Armed Forces, including 1,532 Hoosiers, lost their lives in Vietnam, and more than 300,000 members of the Armed Forces were wounded;*

*Whereas, In 1982, the Vietnam Veterans Memorial was dedicated in Washington, D.C., to commemorate the lives and service of the men and women who died or were declared missing in action in the Vietnam War;*

*Whereas, The Vietnam War was an extremely divisive issue among the people of the United States, and the crossfire of debate about the country's involvement in the war deprived many members of the Armed Forces of public support and appreciation for their patriotic service;*

*Whereas, Civil discourse in the political affairs of the United States should be encouraged, and it is never too late to say, "I am sorry" and "thank you" to our Vietnam veterans;*

*Whereas, The establishment of a yearly Welcome Home Vietnam Veterans Day is an appropriate way to express appreciation and honor the members of the United States Armed Forces, as well as members of the Red Cross and other service organizations, who bravely served the country and their fellow citizens during the Vietnam War; and*

*Whereas, Congress has proclaimed March 30 a national Welcome Home Vietnam Veterans Day and encouraged people of the United States to observe this day with ceremonies and activities that promote awareness of the numerous contributions of veterans who served in Vietnam, and the importance of helping all of America's veterans return home and achieve happy, healthy, and productive lives: Therefore,*

*Be it resolved by the House of Representatives of the General Assembly of the State of Indiana, the Senate concurring:*

SECTION 1. That the Indiana General Assembly urges the Governor to declare March 30 each year as Welcome Home Vietnam Veterans Day.

### House Concurrent Resolution 28

Representatives Truitt and Klinker introduced House Concurrent Resolution 28:

A CONCURRENT RESOLUTION honoring the West Lafayette High School girls soccer team.

*Whereas, The West Lafayette High School girls soccer team accomplished its season's goal of winning a state title by defeating Gibson Southern 2-0;*

*Whereas, The Class A Girls State Championship is the first soccer state title for the school;*

*Whereas, After a scoreless first half, West Lafayette senior forward Shelby Mann scored two goals, giving her a team high 38 goals for the season;*

*Whereas, Senior goalkeeper Emily Field recorded three saves, ensuring the shutout for her team;*

*Whereas, Shelby Mann was named to the 1st Team All State team, becoming the first player in West Lafayette girls soccer history to do so;*

*Whereas, Fifth-rated West Lafayette ended its season with a 15-7 record, including a seven match unbeaten streak;*

*Whereas, In addition to winning the state championship, the Red Devils were also the Hoosier Conference Champions; and*

*Whereas, This outstanding team leaves a historic mark on West Lafayette High School girls soccer with multiple all-conference and all-area accolades in addition to its state championship title: Therefore,*

*Be it resolved by the House of Representatives of the General Assembly of the State of Indiana, the Senate concurring:*

SECTION 1. That the Indiana General Assembly congratulates the West Lafayette High School girls soccer team on its state championship victory and wishes the team members continued success in all their futures.

### House Concurrent Resolution 51

Representatives Clere, Austin and Saunders introduced House Concurrent Resolution 51:

A CONCURRENT RESOLUTION celebrating the 200th birthday of William S. Culbertson and recognizing the historic and cultural significance of the Culbertson Mansion.

*Whereas, Born in New Market, Pennsylvania, on February 4, 1814, William S. Culbertson enjoyed a long career in the dry goods business;*

*Whereas, Arriving in New Albany in 1835, William S. Culbertson married Eliza Vance and together they had eight children;*

*Whereas, With the arrival of his younger brother John Craighead Culbertson, the two partnered together and formed Culbertson and Brother, a successful wholesale/retail business which was later known as Culbertson and Son;*

*Whereas, Active in his community, William S. Culbertson served on the city council of New Albany (2nd Ward) and provided for the needy by creating the Culbertson Widows Home and the Cornelia Memorial Orphans Home;*

*Whereas, William S. Culbertson used his material wealth and business connections to advance New Albany's transportation and utility infrastructure, namely with the Kentucky and Indiana Railroad Bridge, the New Albany Gas Light and Coke Company, the New Albany Water Company, and the First National Bank of New Albany;*

*Whereas, William S. Culbertson's personal residence, the Culbertson Mansion, serves as the crown jewel of New Albany's Mansion Row Historic District and opened as a museum in 1966;*

*Whereas, Listed on the National Register of Historic Places, the Culbertson Mansion became one of Indiana's State Historic Sites in 1976 and stands as a testament to the family's influence during the late 19th century;*

*Whereas, The Culbertson Mansion is an integral part of the Indiana State Museum system and stands as an example of the value the State Museum has in maintaining and preserving the history of our great state;*

*Whereas, For nearly 50 years, visitors to the mansion have learned about Victorian era lifestyles, experienced social and cultural history through interpretation, and witnessed a remarkable restoration of the home's Gilded Age opulence; and*

*Whereas, William S. Culbertson and his spectacular mansion are a large part of the history of Indiana that should be maintained for the generations that are to come: Therefore,*

*Be it resolved by the House of Representatives of the General Assembly of the State of Indiana, the Senate concurring:*

SECTION 1. That the Indiana General Assembly recognizes the many contributions made by William S. Culbertson to the State of Indiana and the nation and to acknowledge the 200th anniversary of his birth.

SECTION 2. That the Principal Clerk of the House of Representatives shall transmit a copy of this resolution to Jessica Stavros, site manager of the Culbertson Mansion.

The resolution was read a first time and adopted by voice vote. The Clerk was directed to inform the Senate of the passage of the resolution. Senate sponsors: Senators Grooms, Merritt and Arnold.

### House Resolution 52

A HOUSE RESOLUTION recognizing the Tri-Central High School football team.

*Whereas, The Tri-Central High School football team is the 2013 Class A state football champion;*

*Whereas, The Tri-Central Trojans, ranked number 7 in the state coaches poll and number 8 by the Associated Press, ended the season with a 14-1 record;*

*Whereas, Garrett Kelley led Tri-Central with 78 rushing yards, Cody Howell passed for 167 yards on 7-of-10 passes, and Jade Pickett caught four passes for 89 yards; and*

*Whereas, Outstanding accomplishments such as this deserve special recognition: Therefore,*

*Be it resolved by the House of Representatives of the General Assembly of the State of Indiana:*

*Whereas, Bing Welch was a loving husband, father, and grandfather who devoted his life to serving his community with honesty, commitment, and integrity: Therefore,*

*Whereas, The effects of violent relationships are long-lasting and put victims at a higher risk of substance abuse, eating disorders, attempting suicide, further domestic violence, and partaking in risky sexual behaviors leading to higher rates of pregnancy and sexually transmitted diseases;*

*Whereas, Dating violence comes in many forms, including physical abuse, verbal/emotional abuse, sexual abuse, and digital abuse;*

*Whereas, The ten warning signs of abuse are checking cell phones and emails without permission, constantly putting the partner down, extreme jealousy or insecurity, explosive tempers, isolating the partner from family or friends, making false accusations, mood swings, physical harm, possessiveness, and telling the partner what to do;*

*Whereas, Anyone who feels they are in an abusive relationship is encouraged to speak up and get help; and*

*Whereas, Teen Dating Violence Awareness and Prevention Month is sponsored by Break the Cycle, a leading national voice for the issue that partners with numerous organizations, including the White House, MTV, the National Dating Abuse Hotline, Loveisrespect, The Allstate Foundation, Avon, and Mary Kay, to provide resources for those in need: Therefore,*

*Be it resolved by the Senate  
of the General Assembly of the State of Indiana,  
the House of Representatives concurring:*

The courthouse is the only original log courthouse still standing in the Northwest Territory. Although it has been moved three times, the log courthouse maintains the integrity of when it was first built over 200 years ago; and*

*Whereas, Centerville will celebrate its bicentennial anniversary in 2014: Therefore,*
