**RESOLUTIONS ON FIRST READING****House Resolution 22**

Representative Zent introduced House Resolution 22:

A HOUSE RESOLUTION recognizing the Rho chapter of Psi Iota Xi.

*Whereas, Psi Iota Xi was founded in 1897 by the joining together of women to make a difference in the lives of individuals one community at a time;*

*Whereas, The Rho chapter of Psi Iota Xi in Angola was established in June 1916;*

*Whereas, 2016 marks the 100th anniversary of the Rho chapter of Psi Iota Xi in Angola;*

*Whereas, Psi Iota Xi was originally founded to bring more diverse cultural experiences to communities;*

*Whereas, Music, art, and literature were introduced into these communities using the funds raised by Psi Iota Xi members;*

*Whereas, Today's members, through a growing sphere of interest, are able to help those with speech and hearing difficulties;*

*Whereas, Each chapter of Psi Iota Xi is based upon the needs of each community and endeavors to create a circle of influence and dedication to meet the diverse needs of individuals, families, and communities of our states and nation; and*

*Whereas, Psi Iota Xi is a network of friends dedicated to helping others: Therefore,*

*Be it resolved by the House of Representatives of the General Assembly of the State of Indiana:*

SECTION 1. That the Indiana House of Representatives congratulates the Rho chapter of Psi Iota Xi in Angola on the occasion of the 100th anniversary of its founding and thanks the members for all their good work.

SECTION 2. That the Principal Clerk of the House of Representatives shall transmit a copy of this resolution to the members of the Rho chapter of Psi Iota Xi in Angola.

**House Concurrent Resolution 27**

Representatives Porter, T. Brown, Bartlett, C. Brown, Harris, Pryor, Shackelford, V. Smith, Summers, Pelath, Baird and Lehman introduced House Concurrent Resolution 27:

A CONCURRENT RESOLUTION urging the Indiana Department of Transportation to name the section of Interstate 70 from Brazil to Indianapolis and the section of Interstate 65 from Seymour to Indianapolis as "The Tuskegee Airmen Highway".

*Whereas, The Tuskegee Airmen were a group of dedicated, determined young men who volunteered to become America's first African-American military airmen;*

*Whereas, Tuskegee University was awarded the United States Army Air Corps contract to help train these brave young men because it had an airfield and a proven civilian pilot training program, and because its graduates performed highest on flight aptitude exams;*

*Whereas, Approximately 1,000 African-American pilots were trained at Tuskegee University between 1941 and 1946;*

*Whereas, The all African-American 332nd Fighter Group originally consisted of four fighter squadrons — the 99th, the 100th, the 301st, and the 302nd;*

*Whereas, The 332nd Fighter Group's success in escorting bombers during World War II is a record unmatched by any other fighter group, having one of the lowest loss records of all the escort fighter groups;*

*Whereas, The Airmen flew more than 700 bomber escort missions and ended the war as the only fighter group to never lose an escorted bomber to enemy fighters;*

*Whereas, The Fighter Group received numerous awards and citations for their bravery and tenacious fighting ability, including several Presidential Unit Citations;*

*Whereas, Indiana has a significant connection to the Tuskegee Airmen legacy;*

*Whereas, Indianapolis native Charles DeBow was a member of the first class of five graduates of the Tuskegee Advanced Flying School; Brazil native Charles Hall was the first African-American military aviator to shoot down an enemy plane in air-to-air combat; and Freeman Field in Seymour was the location of the Freeman Field Mutiny, where more than 100 Tuskegee airmen were arrested for refusing to sign an illegal order of segregation of the officers' club; and*

*Whereas, Accomplishments such as these deserve special recognition so that all Americans can remember the bravery and courage of the Tuskegee Airmen in the face of great personal danger: Therefore,*

*Be it resolved by the House of Representatives of the General Assembly of the State of Indiana, the Senate concurring:*

SECTION 1. That the Indiana General Assembly recognizes the many contributions made by the Tuskegee Airmen during World War II, and in order to perpetuate the history of African-Americans who participated in air crew, ground crew, and operations support training in the Army Air Corps, urges the naming of the section of Interstate 70 from Brazil to Indianapolis and the section of Interstate 65 from Seymour to Indianapolis as "The Tuskegee Airmen Highway".

SECTION 2. That the Principal Clerk of the House of Representatives shall transmit a copy of this resolution to Reginald A. DuValle, president of the Indianapolis Chapter of Tuskegee Airmen, Inc., and to the commissioner of the Indiana Department of Transportation.

The resolution was read a first time and referred to the Committee on Roads and Transportation.

### House Concurrent Resolution 28

Representatives Dermody and Pelath introduced House Concurrent Resolution 28:

A CONCURRENT RESOLUTION urging the Indiana Department of Transportation to rename that part of the road from the city limits on the northeast side of LaPorte along State Road 2 to the intersection with U.S. Highway 20 at Rolling Prairie as the "Governor Harold W. Handley Highway".

*Whereas, Governor Handley was a native of LaPorte who served in the U.S. Army as a Lieutenant Colonel in World War II;*

*Whereas, Governor Handley began his political career as a State Senator and served as President of the Senate from 1940 to 1941;*

*Whereas, Governor Handley served as Lieutenant Governor from 1953 until 1957 and as the 40th Governor of Indiana from 1957 until 1961;*

*Whereas, During his tenure, economic infrastructure was expanded in Indiana through the creation of a veterinary school at Purdue University as well as securing grants for the land at the Lake Michigan port location;*

*Whereas, Governor Handley eliminated a majority of the property taxes during his tenure;*

*Whereas, Governor Handley personally advocated for mental health reform and expanded state programs in support of mentally ill and disabled Hoosiers and remained dedicated throughout his life to several charities that worked to help the mentally disabled;*

*Whereas, Even after retirement, Governor Handley continued to assist his predecessors as part of the Constitutional Revision Commission; and*

*Whereas, This outstanding Hoosier deserves special recognition: Therefore,*

*Be it resolved by the House of Representatives of the General Assembly of the State of Indiana, the Senate concurring:*

SECTION 1. That the Indiana General Assembly urges the Indiana Department of Transportation to rename that part of the road from the city limits on the northeast side of LaPorte along

State Road 2 to the intersection with U.S. Highway 20 at Rolling Prairie as the "Governor Harold W. Handley Highway".

SECTION 2. That the Principal Clerk of the House of Representatives shall transmit a copy of this resolution to the commissioner of the Indiana Department of Transportation.

*Whereas, The Art League has provided 50 years of volunteer support to the Art Museum of Greater Lafayette;*

*Whereas, The Art League offers and supports educational and fundraising activities, exhibitions, and programs;*

*Whereas, The Art League acquires works of art for the permanent collection of the Art Museum of Greater Lafayette;*

*Whereas, The Art League provides funding for art education scholarships for children and adults;*

*Whereas, The Art League provides members with opportunities for individual creative and artistic experiences;*

*Whereas, The Art League fosters the appreciation of art and artists in the Greater Lafayette community;*

*Whereas, The Art League provides funding for artists to beautify areas within community spaces;*

*Whereas, The Art League has established an endowment to sustain its support in honor of its 50th anniversary; and*

*Whereas, The Art League of the Art Museum of Greater Lafayette is celebrating its 50th anniversary: Therefore,*

*Be it resolved by the House of Representatives of the General Assembly of the State of Indiana, the Senate concurring:*

SECTION 1. That the Indiana General Assembly congratulates the Art League of the Art Museum of Greater Lafayette on 50 years of service to the community and recognizes the beauty the Art Museum of Greater Lafayette brings into our lives.

SECTION 2. That the Principal Clerk of the House of Representatives transmit a copy of this resolution to Linda Sorensen, President of the Art Museum of Greater Lafayette.

A CONCURRENT RESOLUTION to increase the awareness and understanding of dyslexia among Hoosiers.

*Whereas, Dyslexia is a specific learning disability that is neurological in origin and is characterized by difficulties with accurate and/or fluent word recognition and by poor spelling and decoding abilities;*

*Whereas, These difficulties typically are caused by a deficit in the phonological component of language that is unexpected in relation to other cognitive abilities and to the provision of effective classroom instruction;*

*Whereas, Dyslexia is highly prevalent, affecting one out of five individuals, occurring on a continuum of severity, and is persistent and lifelong;*

*Whereas, Dyslexia creates unique challenges for students resulting in significant educational implications which need to be addressed;*

*Whereas, Hoosiers will benefit from increased awareness of the nature of dyslexia, the early warning signs of dyslexia, and the value of proven, evidence-based, multisensory, and structured language interventions for students with dyslexia;*

*Whereas, The Scottish Rite Cathedral is recognized for conducting the free-of-charge Children's Dyslexia Center of Indianapolis, directed by the distinguished Julie Bohannon;*

*Whereas, Cheryl Clemens, Nanci Perry, Mary Binnion, and LeAnn Bricker have worked diligently to bring dyslexia awareness to Hoosier schools and communities through Decoding Dyslexia – Indiana; and*

*Whereas, Greater recognition and understanding are necessary to ensure individuals with dyslexia are accurately identified and provided with appropriate services so they can lead maximally productive lives: Therefore,*

*Be it resolved by the House of Representatives of the General Assembly of the State of Indiana, the Senate concurring:*

SECTION 1. That the Indiana General Assembly wishes to increase the awareness of the number of Hoosiers affected by dyslexia, the symptoms of dyslexia, and the treatment for dyslexia.

SECTION 2. That the Principal Clerk of the House of Representatives shall transmit a copy of this resolution to Cheryl Clemens, Co-Founder of Decoding Dyslexia.

The resolution was read a first time and adopted by voice vote. The Clerk was directed to inform the Senate of the passage of the resolution. Senate sponsor: Senator Bray.

### House Concurrent Resolution 31

Representative Koch introduced House Concurrent Resolution 31:

A CONCURRENT RESOLUTION memorializing Indiana State Police Trooper Robert Gillespie and urging the Indiana Department of Transportation to rename that part of State Road 37 between Bedford and Mitchell "The Trooper Robert Gillespie Memorial Highway".

*Whereas, Trooper Robert Gillespie was killed in a traffic accident on Friday, June 8, 1962, while rushing to a call for assistance near Mitchell in Lawrence County;*

*Whereas, While traveling with his emergency lights on, Trooper Gillespie was forced to leave the road when a pickup truck slowed in front of him;*

*Whereas, Leaving the highway to avoid the pickup truck, Trooper Gillespie swerved back on the highway to avoid another car in his path when a third car struck his vehicle;*

*Whereas, Trooper Gillespie served with the Indiana State Police for nearly 12 years and was assigned to the Seymour post;*

*Whereas, In 1959, Trooper Gillespie was awarded the Indiana State Police Gold Star Award for Valor when, in spite of gunshot wounds, he continued to pursue a couple who had fired at him;*

*Whereas, Trooper Gillespie was also a United States Navy veteran serving in the Shore Patrol; and*

*Whereas, The valor and courage displayed by Trooper Gillespie deserve special recognition: Therefore,*

*Be it resolved by the House of Representatives of the General Assembly of the State of Indiana, the Senate concurring:*

SECTION 1. That the Indiana General Assembly recognizes the bravery of Trooper Robert Gillespie by urging the Indiana Department of Transportation to rename that section of State Road 37 between Bedford and Mitchell "The Trooper Robert Gillespie Memorial Highway".

SECTION 2. That the Principal Clerk of the House of Representatives shall transmit a copy of this resolution to the family of Indiana State Police Trooper Robert Gillespie.

The resolution was read a first time and referred to the Committee on Roads and Transportation.

*Whereas, In January 1986, Governor Robert D. Orr appointed Brent E. Dickson to the Indiana Supreme Court, making Justice Dickson the state's 100<sup>th</sup> Supreme Court justice;*

*Whereas, Justice Dickson has become the longest serving justice on the court since 1853;*

*Whereas, Justice Dickson's tenure has been marked by his efforts to enhance attorney civility, increase lawyer pro bono legal services, encourage mediation, and support the jury trial system;*

*Whereas, Over his 30 years on the bench, Justice Dickson authored 884 civil and criminal opinions and chaired several committees, including the Indiana Supreme Court's Records Management Committee, Judicial Data Processing Oversight Committee, and the Task Force for Public Access to Court Records, in addition to serving on national committees such as the Committee on Rules of Practice and Procedure of the Judicial Conference of the United States;*

*Whereas, As a culmination of his dedication to and leadership on the Indiana Supreme Court, Justice Dickson served as Chief Justice from May 2012 until August 2014;*

*Whereas, Justice Dickson has also continued to contribute his talents off of the bench, serving as an adjunct professor of Indiana Constitutional Law at both Indiana University's Mauer*

*School of Law and Indiana University's Robert H. McKinney School of Law, as well as serving as a co-founder of the Sagamore Chapter of the American Inns of Court, an organization aimed at promoting lawyer civility and professionalism;*

*Whereas, Prior to his appointment to the Indiana Supreme Court, Justice Dickson spent 17 years as a general practice lawyer in Lafayette, Indiana;*

*Whereas, Justice Dickson received his B.A. from Purdue University in 1964, his J.D. from Indiana University Robert H. McKinney School of Law in 1968, and a honorary doctor of letters degree from Purdue University in 1996; and*

*Whereas, Upon his retirement in April 2016, Justice Dickson plans on spending time with his loving wife, Jan Aikman Dickson, and their three sons and nine grandchildren, while continuing to serve as a private mediator and senior judge: Therefore,*

*Be it resolved by the Senate  
of the General Assembly of the State of Indiana,  
the House of Representatives concurring:*

SECTION 1. That the Indiana General Assembly honors Justice Brent E. Dickson upon his retirement from the Indiana Supreme Court after 30 years of distinguished service.

SECTION 2. The Secretary of the Senate is hereby directed to transmit a copy of this Resolution to Justice Brent E. Dickson.

The resolution was read a first time and adopted by voice vote. The Clerk was directed to inform the Senate of the passage of the resolution.

#### **Senate Concurrent Resolution 10**

*Whereas, Winters was headed to work on the morning of April 10, 2014 when he noticed his elderly neighbor's house ablaze and helped guide the couple and their grandson to safety, after notifying dispatch of the situation;*

*Whereas, After fire departments arrived on the scene, Winters stayed on-scene to help with scene control and traffic;*

*Whereas, When asked about the situation by his fellow coworkers, he remained modest about his involvement and they were not aware of his heroism until a firefighter later notified the Indiana State Police Lafayette Post about the full details of the events of the fire;*

*Whereas, With Winters efforts, three people's lives were saved, at the potential cost of his own, which was why he was chosen by AAST for this distinguished honor from a national pool of candidates; and*

*Whereas, A ceremony for Winters to receive the award was held on August 3, 2015 at the Lafayette State Police Post in recognition of his efforts: Therefore,*

*Be it resolved by the Senate  
of the General Assembly of the State of Indiana,  
the House of Representatives concurring:*

SECTION 1. That the Indiana General Assembly honors the

bravery of Senior Trooper J. Ryan Winters and the accomplishment of being named the 2015 National Trooper of the Year.

SECTION 2. The Secretary of the Senate is hereby directed to transmit a copy of this Resolution to Senior Trooper J. Ryan Winters.

The resolution was read a first time and adopted by voice vote. The Clerk was directed to inform the Senate of the passage of the resolution.

#### **Senate Concurrent Resolution 28**

*Whereas, In 2015, the Airport was honored by Airports Council International as the Best Airport in North America for the 4th time in the last 5 years, is one of the few airports in the world to receive the Director General's Roll of Excellence Award, and was identified as the Best Airport in America by a Reader's Choice Survey conducted nationwide by Conde Nast Traveler;*

*Whereas, The Airport also received a Monumental Award in 2015 in the category of Real Estate Development from the Indianapolis Chamber of Commerce for its new land use initiatives that have returned airport land, no longer needed for aviation, back into productive use for generating property taxes for neighboring communities, business opportunities, and jobs for Central Indiana; and*

*Whereas, In the past year, the Airport has experienced significant increases in air service, including the addition of three new airlines and 13 new non-stop flights, while annual passenger traffic grew by nearly seven percent and overall capacity by ten percent, the best year in more than a decade: Therefore,*

*Be it resolved by the Senate  
of the General Assembly of the State of Indiana,  
the House of Representatives concurring:*

SECTION 1. That the Indiana General Assembly recognizes the Indianapolis International Airport's continual excellence in customer service and operational performance.
