A SENATE RESOLUTION honoring the life and accomplishments of Major General Robert J. Mitchell.

Whereas, Robert J. Mitchell was born November 4, 1936 to parents Robert D. and Charlotte (Stewart) Mitchell;

Whereas, Robert began his military career in September 1953, when he enlisted in the Army Reserve and served as a military police officer with the 341st Military Police Company;

Whereas, From 1955 to 1959, Robert served on active duty as an Operations Specialist and Communications Chief with the field artillery in the Individual Ready Reserve and then enlisted in Company D. 1st Battalion, 152nd Infantry;

Whereas, Robert married Carolyn Ward on May 29, 1964 at Winslow Christian Church in Winslow, Indiana;

Whereas, Robert attended the Indiana Military Academy and was commissioned as a Second Lieutenant on July 12, 1964;

Whereas, After being commissioned to serve as a Weapons Platoon Leader for Company B, 1st Battalion, 152nd Infantry, Robert continued serving the battalion for 14 years in a number of capacities: Liaison Officer, Company Executive Officer, Headquarters Company, C Company Commander, Battalion Operations and Training Officer (S-3 Air), Operations and Training Officer (S-3), and two stints as the Battalion Executive Officer;

Whereas, Robert's other duty assignments include Operations and Training Officer (S-3) for 76th Brigade 38th Infantry, Director of Industrial Operations at Camp Atterbury, Executive Officer for Camp Atterbury, Battalion Commander of the 1st Battalion 152nd Infantry Military Support Officer, Headquarters Detachment STARC, Indiana Army National Guard, Commander 2d Brigade 38th Infantry Division, Assistant Adjutant General (Army) for the State of Indiana, Assistant Division Commander 38th Infantry Division, and Deputy STARC Commander INARNG;

Whereas, Robert was promoted to the rank of Major General and assumed command of the 38th Infantry Division (Mechanized) on August 7, 1995;

Whereas, Governor Frank O'Bannon appointed Robert as the Adjutant General for the Indiana Army and Air National Guard in January 1997;

Whereas, After his military career, Robert worked in the coal industry, was a lobbyist for the Indiana and Illinois Coal Council, and taught mining technology as an associate professor for Vincennes University;

Whereas, During his retirement, Robert stayed active internationally as an Army Advisory to the Country of Georgia to prepare them for admission into NATO, and was an honorary member of the General's Club in Slovakia;

Whereas, Robert received numerous awards and accolades during his life, including two Sagamore of the Wabash, the title of "Kentucky Colonel", an honorary doctorate from Oakland City University, was a knighted member of the Sovereign Military Order of the Temple of Jerusalem, and was a lifetime member of Petersburg VFW Post 3587;

Whereas, When not working, Robert enjoyed passing the time by traveling, reading, and spending time with his family; and

Whereas, The passing of Robert leaves a hole in the hearts of his family, friends, and the community, but his legacy will not be forgotten: Therefore,

Be it resolved by the Senate of the General Assembly of the State of Indiana:

Whereas, Pat's commitment to quality education has led her to work at the National Education Association (NEA) in a number of capacities, including chairing the Black Caucus, co-chairing the Minority Affairs Committee, and serving as a member of the Civil Rights Committee, the Board of Directors, the Instructional and Professional Development Committee, and was the NEA representative at a number of national and international events;

Whereas, Pat's dedication has been apparent and appreciated by many throughout the years, and she was awarded the 1984 IPS Teacher of the Year, 1985 Finalist for State Teacher of the Year, an Honorary Doctorate of Humane Letters from Martin

University in 1990, the 1994 Black Woman of the Year Award from Asiatic Productions, the NAACP Education Award, the Excellence Award from the Division of Equal Opportunity for the City of Indianapolis, the Indianapolis Education Association's Human Rights Award, the key to the city of Muncie in 2001, Best Practices in the field of Multicultural Education from the Indiana Civil Rights Commission, the Drum Major Award in Education from Circle City Frontiers International, the Stacey Toran Foundation's 2002 Achievement in Education Award, the Diversity Torchbearer Award from the African Community International Center, the 2004 Diamond Award from 100 Black Men Indianapolis Chapter, the 2005 Martin Luther King Jr. Human Rights Award for Leadership in Education from the Indianapolis Education Association, the 2007 Lifetime Achievement Award from the Indianapolis Professional Association, the 2010 Living Legend Award from Community Action of Greater Indianapolis, the 2012 Senator Julia Carson Community Service Award, the 2013 Distinguished Alumni Award from Indiana University, and more;

Whereas, Pat has also presented at a plethora of conferences and programs, instructed at IUPUI about education, consulted with businesses on the topics of education and diversity, been a certified trainer for REACH (Respecting Ethnic and Cultural Heritage) and the Intercultural Development Inventory (IDI), served as a delegate and alternate delegate to the Democratic National Convention, hosted and produced the cable television show "Multicultural Points and Perspectives," and has been a graduation keynote speaker;

Whereas, When not working, Pat enjoys staying active in her church, the Witherspoon Presbyterian Church, where she is an ordained Elder, and spending time with her husband Jerome, daughter Kristie King, and grandchildren Michael and Myles;
