## RESOLUTIONS ON FIRST READING

### House Concurrent Resolution 33

Representatives VanNatter and Moed introduced House Concurrent Resolution 33:

A CONCURRENT RESOLUTION recognizing the 100th anniversary of the Indiana CPA Society.

*Whereas, Enabling legislation passed by the Indiana General Assembly in March 1915 established the certified public accountant (CPA) profession in Indiana;*

*Whereas, The Indiana Association of Certified Public Accountants (IACPA) was formed in May 1915 to represent CPAs in the state of Indiana;*

*Whereas, The IACPA became known as the Indiana CPA Society in 1979;*

*Whereas, Since its inception 100 years ago, the association now known as the Indiana CPA Society (INCPAS) has existed to serve and support its members who are CPAs in the state of Indiana;*

*Whereas, Today the mission of INCPAS is to enhance the professional success of its members while respecting the public interest, encourage and facilitate the adherence to high ethical and professional standards, facilitate relationships that will benefit its members, promote a better understanding of services rendered by CPAs, and represent the profession;*

*Whereas, More than 8,000 INCPAS members work in the areas of public accounting, business and industry, education, government, and not-for-profit;*

*Whereas, Indiana CPAs are trusted business advisers who have contributed to the success of Indiana businesses for 100 years;*

*Whereas, Indiana CPAs possess a variety of expertise and provide a variety of services that offer accurate financial information and projections that keep Indiana businesses and the state's economy on track for future growth; and*

*Whereas, The CPA profession in Indiana and the Indiana CPA Society will celebrate its centennial anniversary in 2015:*  
*Therefore,*

*Be it resolved by the House of Representatives of the General Assembly of the State of Indiana, the Senate concurring:*

SECTION 1. That the Indiana General Assembly and the residents of Indiana join INCPAS members in celebrating the society's 100-year milestone and its long history of successful achievements on behalf of its members and the state of Indiana during the week of May 10-16, 2015.

SECTION 2. That the Principal Clerk of the House of Representatives transmit a copy of this resolution to the Indiana CPA Society.

### Senate Concurrent Resolution 20

*Whereas, Andrea Hess was named the 2014-2015 Rural Teacher of the Year by the Indiana Small and Rural Schools Association;*

*Whereas, A sixth grade math teacher at George Rogers Clark Middle School, Hess also serves as head of the school's math department,*

*Whereas, Hess is the wife of local Vincennes farmer, Matthew Hess;*

*Whereas, Hess was also a finalist for recognition as the National Rural Teacher of the Year;*

*Whereas, Joining her fellow Rural Teachers of the Year from across the nation, Hess attended the Rural Teachers of the Year Luncheon in San Antonio at the National Rural Education Association Conference in October 2014;*

*Whereas, Governor Mike Pence has formally congratulated Hess for her accomplishments;*

*Whereas, Indiana Superintendent of Public Instruction, Glenda Ritz, also sent a congratulatory letter and visited Vincennes to meet with Hess and take her out to lunch; and*

*Whereas, It is fitting that the Indiana General Assembly gives special recognition to Andrea Hess for being named the 2014-2015 Indiana Rural Teacher of the Year: Therefore,*

*Be it resolved by the Senate  
of the General Assembly of the State of Indiana,  
the House of Representatives concurring:*

SECTION 1. That the Indiana General Assembly recognizes Andrea Hess for being named the 2014-2015 Rural Teacher of the Year by the Indiana Small and Rural Schools Association.

SECTION 2. The Secretary of the Senate is hereby directed to transmit copies of this Resolution to Andrea Hess; Ryan Clark, Principal of the George Rogers Clark Middle School; Greg Parsley, Superintendent of Vincennes Community Schools; J. Scott Turney, Executive Director of the Indiana Small and Rural Schools Association; and the Board of Trustees for the Vincennes Community School Corporation.

Page 3, line 14, delete "(C)" and insert "(B)".

Page 3, delete lines 15 through 17, begin a new line double block indented and insert:

**"(C) Complete construction design plans for the comprehensive care health facility have been submitted to the state department and the division of fire and building safety not later than March 1, 2015. The construction design plans must be an accurate and true depiction of the comprehensive care health facility that the applicant intends to construct. However, the construction design plans may be modified to make technical changes, correct errors and omissions, or comply with zoning or other requirements from a governmental entity."**

Page 3, line 18, delete "(E)" and insert "(D)".

Page 3, delete lines 21 through 23.

Page 5, line 23, after "house" insert "health".

(Reference is to SB 460 as printed February 4, 2015.) and when so amended that said bill do pass.
