## RESOLUTIONS ON FIRST READING

### House Resolution 40

Representatives Karickhoff, Frizzell and Smaltz introduced House Resolution 40:

A HOUSE RESOLUTION urges the United States Forest Service to establish an off-road vehicles (ORVs) trail system.

*Whereas, Off-road vehicles (ORVs) are used by many Americans for recreation and work-related activities;*

*Whereas, Many national forests in Michigan, Kentucky, and Ohio allow the use of ORVs on designated forest trails;*

*Whereas, Currently the Hoosier National Forest does not allow the use of ORVs on any trails; and*

*Whereas, The creation or designation of trails for the general use of ORVs in the Hoosier National Forest would encourage greater outdoor recreation and economic benefits for rural communities near the Hoosier National Forest and Indiana at large: Therefore,*

*Be it resolved by the House of Representatives of the General Assembly of the State of Indiana:*

SECTION 1. That the Indiana House of Representatives urges the United States Forest Service to establish an ORV trail system utilizing the full 15,300 acres identified in the Off-Road Vehicle Used Areas (1987) to allow greater use of the Hoosier National Forest for the recreational and economic benefit of the citizens of the State of Indiana.

SECTION 2. That the Indiana House of Representatives urges a timely administrative process for this action through an amendment or similar appropriate alteration to the current Land and Resource Management Plan and Travel Management Plan.

SECTION 3. That the Principal Clerk of the House of Representatives shall transmit a copy of this resolution to Tony Tooke, Chief of the United States Forest Service.

The resolution was read a first time and referred to the Committee on Natural Resources.

**House Resolution 41**

Representative Karickhoff introduced House Resolution 41:

A HOUSE RESOLUTION recognizing a memorial dedicated to forgotten women who have worked, served, fought, and died defending our country.

*Whereas, The Howard County Veterans Memorial Corporation is designing a new monument that will be the first of its kind in Indiana or the nation;*

*Whereas, The Howard County Veterans Memorial Corporation is developing a monument to women who have worked, served, fought, and died defending our country;*

*Whereas, The monument, to be called The Women's Legacy Memorial, will be situated on the northeast corner of the Howard County Courthouse;*

*Whereas, This memorial will serve as a way to bring to light the accomplishments of Hoosier women that served their country honorably and bravely and are often forgotten;*

*Whereas, Over 33,000 women veterans reside in Indiana; they served in every war period, including World War II, and 1,087 of them are military retirees; and*

*Whereas, Women veterans deserve some sort of special recognition honoring their many contributions: Therefore,*

*Be it resolved by the House of Representatives of the General Assembly of the State of Indiana:*

SECTION 1. That the Indiana House of Representatives supports the Howard County Veterans Memorial Corporation in its effort to erect a monument to women who have worked, served, fought, and died defending our country .

SECTION 2. That the Principal Clerk of the House of Representatives shall transmit a copy of this resolution to the Howard County Veterans Memorial Corporation.

The resolution was read a first time and adopted by voice vote.

**House Concurrent Resolution 58**

Representatives Olthoff, Aylesworth, C. Brown, Candelaria Reardon, Harris, Slager and V. Smith introduced House Concurrent Resolution 58:

A CONCURRENT RESOLUTION recognizing Debbie Rzepczynski, Lake County Public Library employee.

*Whereas, In 2017, Debbie Rzepczynski, a Lake County Public Library employee, received the Indiana Library Federation Volunteer Award;*

*Whereas, The Federation Volunteer Award honors and recognizes an individual who has rendered outstanding service to the Indiana Library Federation and has made significant contributions toward furthering the goals of the Indiana Library Federation;*

*Whereas, Debbie Rzepczynski grew up in the Lake County Public Library (LCPL) system;*

*Whereas, Over the past 30 years, she has held numerous positions throughout the library's branch locations, as well as the audiovisual department, reference department, and administration, becoming LCPL's first library skills trainer in 2012, a position she still holds today;*

*Whereas, Debbie joined the Indiana Library Federation before 1990, when there weren't many audiovisual program*

*offerings, and discovered her niche in helping to set up overhead projectors in the conference meeting rooms;*

*Whereas, Making the transition to LCD projectors and computers, Debbie continues to set up conference rooms at each Indiana Library Federation Annual Conference;*

*Whereas, Debbie's undergraduate background is from Purdue University, where she majored in Radio/TV/Film, and she followed with a Master of Library Science from Indiana University; and*

*Whereas, Debbie spends her quiet time taking photographs of her therapy dog, her drag racing husband, and their friends: Therefore,*

*Be it resolved by the House of Representatives of the General Assembly of the State of Indiana, the Senate concurring:*

SECTION 1. That the Indiana General Assembly wishes to recognize the many contributions and accomplishments of Debbie Rzepczynski.

SECTION 2. That the Principal Clerk of the House of Representatives shall transmit a copy of this resolution to Debbie Rzepczynski and her family.

The resolution was read a first time and adopted by voice vote. The Clerk was directed to inform the Senate of the passage of the resolution. Senate sponsors: Senators Melton, MrVan, Niemeyer and Randolph.

**House Concurrent Resolution 59**

Representatives Olthoff, Aylesworth, C. Brown, Candelaria Reardon, Harris, Slager and V. Smith introduced House Concurrent Resolution 59:

A CONCURRENT RESOLUTION recognizing the Lake County Public Library.

*Whereas, In 2017, the Lake County Public Library (LCPL) received the Indiana Library Federation Outstanding Library Award;*

*Whereas, The Outstanding Library Award honors and recognizes either outstanding library service, which consistently exceeds the expectations of the users and serves as an exemplary model for other libraries, or notable expansion or improvement of service based on cooperation with other libraries or community organizations;*

*Whereas, The Lake County Public Library (LCPL) system was established in 1952, thanks to the Public Library Law of 1947;*

*Whereas, As a fledgling library, LCPL contracted with the Gary Public Library for many services until 1959, when LCPL became a fully independent system;*

*Whereas, The first library headquarters was located in Merrillville, and the system employed 24 staff members; over the years LCPL added many locations throughout Lake County, including a Carnegie library in Hobart;*

*Whereas, Today, LCPL is Indiana's third largest library, comprising nine locations serving 13 communities, serving a diverse community and is known for its free English as a Second Language and citizenship courses;*

*Whereas, LCPL also offers extensive online resources, including research tools for students and businesses, streaming movies, music, eBooks and audiobooks;*

*Whereas, For this award, the Indiana Library Federation received many letters in which patrons, community members, collaborative partners, and neighboring libraries described their own examples of Lake County Public Library's*

*outstanding service; for example, neighboring library directors praised LCPL's collaborative leadership in its marketing campaign, "How do you library?" and its Digital Access Cards for students, recently expanding access to these resources by issuing 44,000 digital access cards throughout the library's school districts, ensuring that students and teachers have a simple way to use some of the best online tools available for education;*

*Whereas, LCPL's attention to its staff and staff morale was noted by partners, citing numerous examples of ways LCPL staff are encouraged to collaborate in the community; and*

*Whereas, LCPL is led by director Ingrid Norris and is supported by 207 staff members, a very active board of trustees, the Lake County Public Library Foundation, and the Friends of Lake County Public Library: Therefore,*

*Be it resolved by the House of Representatives of the General Assembly of the State of Indiana, the Senate concurring:*

SECTION 1. That the Indiana General Assembly congratulates the Lake County Public Library on receiving the Indiana Library Federation Outstanding Library Award.

SECTION 2. That the Principal Clerk of the House of Representatives shall transmit a copy of this resolution to the Lake County Public Library.

The resolution was read a first time and adopted by voice vote. The Clerk was directed to inform the Senate of the passage of the resolution. Senate sponsor: Senators Melton, MrVan, Niemeyer and Randolph.

#### **House Concurrent Resolution 60**

Representatives VanNatter and Karickhoff introduced House Concurrent Resolution 60:

A CONCURRENT RESOLUTION congratulating the Northwestern High School girls basketball team.

*Whereas, The Northwestern High School girls basketball team is the Class 3A state champion;*

*Whereas, The Class 3A state championship started off a bit slowly, but the Tigers used a 16-1 run in the second quarter to take command and roll to a 63-42 win over Greensburg at Bankers Life Fieldhouse, leading by as many as 26 points in the fourth quarter;*

*Whereas, The championship victory gives the top-ranked Northwestern (29-1) Tigers their first state title in program history;*

*Whereas, With this victory, head coach Kathie Layden became the second coach to guide two different schools to a state championship;*

*Whereas, This talented team finished the season on a 22-game winning streak;*

*Whereas, The members of the Indiana High School Athletic Association Executive Committee named Sarah Vas as the winner of the Patricia L. Roy Mental Attitude Award in Class 3A girls basketball; and*

*Whereas, Outstanding accomplishments such as this deserve special recognition: Therefore,*

*Be it resolved by the House of Representatives of the General Assembly of the State of Indiana, the Senate concurring:*

SECTION 1. That the Indiana General Assembly congratulates the Northwestern High School girls basketball team on its Class 3A state championship and wishes the players continued success in all their future endeavors.

SECTION 2. That the Principal Clerk of the House of Representatives shall transmit a copy of this resolution to each team member, team manager, assistant coach, head coach Kathie Layden, Principal Kristen Bilkey, and Superintendent Ryan Snoddy.

The resolution was read a first time and adopted by voice vote. The Clerk was directed to inform the Senate of the passage of the resolution. Senate sponsor: Senator Buck.

#### **House Concurrent Resolution 61**

Representative Lindauer introduced House Concurrent Resolution 61:

A CONCURRENT RESOLUTION honoring the community of Celestine on the occasion of the 175th anniversary of its founding.

*Whereas, Father Joseph Kundek, the priest responsible for several of the county's Catholic churches, platted Celestine in 1843 to build the church, and the community grew around it;*

*Whereas, Celestine was named for the Right Reverend Celestine Rene Lawrence De La Hailandiere, second bishop of the Roman Catholic Diocese of Vincennes;*

*Whereas, The earliest known community history was written by the church's third priest, Father Karl Bilger, and many of its earliest residents are remembered only as they were related to the church;*

*Whereas, In the years since the founding, the community has made a name for itself, particularly in regard to lumber milling and farming;*

*Whereas, According to historical records, as Dubois County became known for woodworking, Celestine became known as the community that supplied the timber;*

*Whereas, The community claims Indiana State Representative Dennis Henry Heeke, who served 34 years in the Indiana General Assembly and has a section of State Road 545 named after him;*

*Whereas, The Celestine area is the home of two American heroes, Marine Corporal Eric Lueken and Lance Corporal Alec Terwiske, who were killed while serving their country;*

*Whereas, The community of Celestine possesses a great sense of community and resilient citizens who have overcome difficult times throughout Celestine's history, including damage from a February 28, 2011, tornado and a 2016 avian flu outbreak; and*

*Whereas, The community of Celestine has greatly contributed to the success of Dubois County and Southwest Indiana over the past 175 years: Therefore,*

*Be it resolved by the House of Representatives of the General Assembly of the State of Indiana, the Senate concurring:*

SECTION 1. That the Indiana General Assembly congratulates the community of Celestine on the occasion of the 175th anniversary of its founding.

SECTION 2. That the Principal Clerk of the House of Representatives shall transmit a copy of this resolution to the community of Celestine, Indiana.

The resolution was read a first time and adopted by voice vote. The Clerk was directed to inform the Senate of the passage of the resolution. Senate sponsor: Senator Houchin.

**House Concurrent Resolution 62**

Representative Lyness introduced House Concurrent Resolution 62:

A CONCURRENT RESOLUTION honoring Mason Parris.

*Whereas, Lawrenceburg High School wrestler Mason Parris is a three time state wrestling champion;*

*Whereas, Senior Mason Parris won his third consecutive 220 pound crown at the Indiana High School Athletic Association (IHSAA) Wrestling State Finals at Bankers Life Fieldhouse in Indianapolis;*

*Whereas, Mason Parris is just the sixth individual to win three state championships in the same weight class and the first since Franklin Central's Jake O'Brien won three straight at 215 pounds from 2001-2003;*

*Whereas, In the title match, Parris (47-0) defeated Merrillville senior Brandon Streck (33-2) by a pin in the second period, marking the 11th title winning pin in his high school career and breaking a record that has stood since 1938;*

*Whereas, Mason Parris's career record is 206-1 with his only loss in high school coming in his freshman year appearance at the state finals, where he narrowly lost in the 182 pound semifinals;*

*Whereas, Mason Parris, who will be wrestling at the University of Michigan, won four matches at the state finals to end his high school wrestling career with a 152 match win streak that dates back to the start of his sophomore season;*

*Whereas, In addition to his championship title, Mason Parris was named the Mental Attitude Award winner in wrestling by the IHSAA; and*

*Whereas, Outstanding accomplishments such as this deserve special recognition: Therefore,*

*Be it resolved by the House of Representatives of the General Assembly of the State of Indiana, the Senate concurring:*

SECTION 1. That the Indiana General Assembly congratulates Mason Parris on winning his third Indiana state wrestling title and wishes him continued success in all his future endeavors.

SECTION 2. That the Principal Clerk of the House of Representatives shall transmit a copy of this resolution to Mason Parris and his family.

The resolution was read a first time and adopted by voice vote. The Clerk was directed to inform the Senate of the passage of the resolution. Senate sponsor: Senator Perfect.

**Senate Concurrent Resolution 49**

The Speaker handed down Senate Concurrent Resolution 49, sponsored by Representative Lyness:

A CONCURRENT RESOLUTION congratulating Nick Goepper on winning the silver medal in men's freeski slopestyle at the 2018 Winter Olympics in PyeongChang, South Korea.

*Whereas, Nick Goepper was born in Fort Wayne, Indiana, in 1994 and moved with his parents and three siblings to Lawrenceburg, Indiana, at a young age;*

*Whereas, At the age of five, Nick was introduced to the sport of skiing by taking lessons in a "Ski-Doodles" program at*

*Perfect North Slopes, the local ski resort, and soon started selling candy bars, mowing lawns, and performing odd jobs in order to pay for additional ski passes;*

*Whereas, Nick began competing in big air skiing at the age of eleven and his family built a backyard training area with PVC pipes and AstroTurf for year-round practice before eventually sending Nick to Oregon at fifteen to attend the action sports school Windells Academy on a full-ride athletic and academic scholarship, which included year-round access to training and coaching;*

*Whereas, Nick obtained multiple podium results, including silver and gold at X Games Aspen, first at Dew Tour Snowbasin, third at Dew Tour Breckenridge, third at the FIS World Championship, and winning his first AFP slopestyle title, all while maintaining a 3.7 GPA at Windells Academy and earning an academic scholarship to Westminster University in Salt Lake City, Utah;*

*Whereas, Following his graduation from Windells Academy in 2013, Nick continued to land on the podium at nearly every event he entered, including multiple World Cup podiums, a win at the Dew Tour, and a second-straight X Games gold medal to set him up for the 2014 Winter Olympics;*

*Whereas, Nick represented the United States in Sochi at the 2014 Olympic Winter Games and made history by taking home the first-ever bronze medal in freeski slopestyle and sweeping the podium with fellow Americans Joss Christensen and Gus Kenworthy;*

*Whereas, After continued success in early 2015, Nick took a pause from skiing to have surgery on his shoulder before returning to the snow in January of 2016;*

*Whereas, Nick placed tenth overall in the 2017 FIS World Cup Standings and received silver at the 2017 X Games Norway and Dew Tour before being named as one of four men's slopestyle freeskiers to represent the United States in the 2018 Olympic Winter Games;*

*Whereas, Nick obtained a best score of 92.8 over two qualification runs to be ranked fifth out of twelve athletes to compete in the men's freeski slopestyle finals;*

*Whereas, After receiving scores outside of medal contention in his first two runs, Nick completed an extremely technical final run, including a left 270 pretzel 450 out, switch left 270 backside 270 out on down flat down, 270 on pretzel 270 out, and nose butter 720 in the rails sections, followed by a left double cork 1260 with a tail grab, switch rightside double misty 1260 with a mute grab, and triple cork 1440 with a mute grab to late Japan grab in the jumps to solidify a score of 93.6 and the silver medal; and*

*Whereas, Nick has been an exemplary representative of southeastern Indiana on the national and international stage and his hard work and dedication to the sport are exhibited through his many achievements and continued success: Therefore,*

*Be it resolved by the Senate of the General Assembly of the State of Indiana, the House of Representatives concurring:*

SECTION 1. That the Indiana General Assembly congratulates Nick Goepper on winning the silver medal in men's freeski slopestyle at the 2018 Olympic Winter Games in PyeongChang, South Korea and wishes him well on his path to the 2022 Olympic Winter Games in Beijing, China.

SECTION 2. The Secretary of the Senate is hereby directed to transmit a copy of this resolution to Nick Goepper
