DIGEST

Superintendent of public instruction and education secretary. Delays the conversion of the office of superintendent of public instruction from an elective office to an appointed office by four years (from calendar year 2021 to calendar year 2025). Establishes minimum qualifications for the secretary of education.

 - 12 **regionally or nationally accredited college or university; and**
 - 13 **(4) either:**
 - 14 **(A) at the time of taking office is licensed or otherwise**
 - 15 **employed as a teacher, principal, or superintendent;**
 - 16 **(B) has held a license as a teacher, superintendent, or**
 - 17 **principal, or any combination of these licenses, for at least**
 - 18 **five (5) years at any time before taking office; or**
 - 19 **(C) has a total of at least five (5) years of work experience**
 - 20 **as any of the following, or any combination of the**
 - 21 **following, before taking office:**
 - 22 **(i) Teacher.**
 - 23 **(ii) Superintendent.**
 - 24 **(iii) Principal.**
 - 25 **(iv) Executive in the field of education."**
