I offer the following resolution and move its adoption:

1           A SENATE RESOLUTION honoring Senator Victoria  
2           Spartz upon her retirement from the Indiana Senate.

4           *honorably served the constituents of District 20, encompassing*  
5           *parts of Hamilton County, since her appointment in 2017;*

6           *Whereas, Senator Spartz has served on the Senate*  
7           *Committees on Education and Career Development,*  
8           *Environmental Affairs, Insurance and Financial Institutions,*  
9           *and Pensions and Labor, and as Chair of the Audit and*  
10           *Financial Reporting Subcommittee of the Legislative Council;*

11           *Whereas, During her tenure in the Senate, Senator Spartz*  
12           *has been an advocate for limited government and business*  
13           *deregulation, fiscal conservatism, and bringing transparency*  
14           *and accountability to state government;*

15           *Whereas, Senator Spartz earned a Bachelor of Science and*  
16           *Master of Business Administration from the National University*  
17           *of Economics (Ukraine);*

5             *Whereas, Before her service in the Senate, Senator Spartz*  
6     *worked as a Certified Public Accountant for Big 4 accounting*  
7     *firms for Fortune 500 companies, as an adjunct faculty member*  
8     *at Indiana University's Kelley School of Business, and as the*  
9     *Chief Financial Officer for the Office of the Indiana Attorney*  
10    *General; and*

11            *Whereas, Senator Spartz's passion for limited government,*  
12    *knowledge of public finance matters, and commitment to*  
13    *conservative principles will be greatly missed within the*  
14    *Indiana Senate and throughout the Statehouse: Therefore,*
