DIGEST OF SB 625 (Updated February 14, 2019 1:25 pm - DI 125)

**Citations Affected:** IC 12-15.

**Synopsis:** Medicaid nursing facility services. Extends the prohibition on the office of Medicaid policy and planning from including certain Medicaid recipients who receive nursing facility services in a Medicaid risk based managed care program or a capitated managed care program through June 30, 2021.

**Effective:** July 1, 2019.

A BILL FOR AN ACT to amend the Indiana Code concerning human services.

*Be it enacted by the General Assembly of the State of Indiana:*

- 1 SECTION 1. IC 12-15-5-17, AS ADDED BY P.L.224-2017,  
2 SECTION 3, IS AMENDED TO READ AS FOLLOWS [EFFECTIVE  
3 JULY 1, 2019]: Sec. 17. (a) This section does not apply to a Medicaid  
4 recipient participating in the Program of All-Inclusive Care for the  
5 Elderly (PACE) program described in IC 12-15-43.  
6 (b) The office may not include a Medicaid recipient who is eligible  
7 to:  
8 (1) participate in the Medicare program (42 U.S.C. 1395 et seq.);  
9 and  
10 (2) receive nursing facility services;  
11 in a risk based managed care program or capitated managed care  
12 program.  
13 (c) This section expires ~~December 31, 2019~~. **June 30, 2021.**
