

HOUSE BILL No. 1303

DIGEST OF INTRODUCED BILL

Citations Affected: IC 20-27-7.

Synopsis: School bus out-of-service orders and certificates. Provides that the driver of a special purpose bus or school bus (bus) at the time of the inspection shall be notified of an out-of-service order and a copy shall be made available on the Internet web site of the state police department. (Current law provides that a copy of the out-of-service order is to be forwarded to the governing body of the school corporation that controls the operation of the bus.)

Effective: July 1, 2014.

HOUSE BILL No. 1303

A BILL FOR AN ACT to amend the Indiana Code concerning education.

Be it enacted by the General Assembly of the State of Indiana:

1 SECTION 1. IC 20-27-7-13, AS ADDED BY P.L.1-2005,
2 SECTION 11, IS AMENDED TO READ AS FOLLOWS [EFFECTIVE
3 JULY 1, 2014]: Sec. 13. If:
4 (1) after being repaired under section 11 of this chapter a special
5 purpose bus or school bus does not meet the minimum standards
6 under this chapter; or
7 (2) a special purpose bus or school bus is not repaired to meet the
8 minimum standards under this chapter;
9 the state police department shall issue an out-of-service order and
10 certificate for the special purpose bus or school bus. ~~Each~~
11 ~~out-of-service order and certificate shall be served personally on~~ The
12 driver of the special purpose bus or school bus **at the time of the**
13 **inspection shall be notified of the out-of-service order** and a copy
14 shall be ~~forwarded to~~ **made available on the Internet web site of the**

2 issued, the affected special purpose bus or school bus may not be used

4 SECTION 2. IC 20-27-7-14.5 IS ADDED TO THE INDIANA
5 CODE AS A NEW SECTION TO READ AS FOLLOWS
6 [EFFECTIVE JULY 1, 2014]: **Sec. 14.5. After:**

7 **(1) an out-of-service order and an out-of-service certificate**
8 **have been issued under section 13 of this chapter; and**

9 **(2) the out-of-service certificate has been displayed or**
10 **positioned as set forth in section 14 of this chapter;**

11 **the affected special purpose bus or school bus may not be used to**
12 **transport passengers until all defects have been corrected.**
