1           A HOUSE RESOLUTION recognizing the "Keep  
2 Noblesville Beautiful" organization.

3           *Whereas, "Keep Noblesville Beautiful" is a community*  
4 *improvement organization providing educational and*  
5 *community action programs to the general public in the*  
6 *Noblesville area;*

7           *Whereas, These programs help government, businesses, and*  
8 *citizens work together to provide litter prevention and cleanup,*  
9 *neighborhood beautification, and other services that help make*  
10 *a healthy and safe community and provide a viable and*  
11 *sustainable impact on the lives of residents;*

12           *Whereas, "Keep Noblesville Beautiful" has partnered with*  
13 *organizations such as the Hamilton County Master Gardener*

6 Whereas, "Keep Noblesville Beautiful" has given away over  
 7 1,800 tree saplings, recycled almost 8,000 pounds of metal,  
 8 planted over 15,000 daffodil bulbs at city gateways, assisted  
 9 over 250 homeowners with landscaping needs, collected over  
 10 750 bags of trash along Highway 37, recycled over 475,000  
 11 pounds of paper, and brought together over 850 volunteers who  
 12 assisted with beautification projects in Historic Downtown  
 13 neighborhoods, Federal Hill Commons, Belfry Theatre,  
 14 Noblesville Post Office, and North and Noble Crossing  
 15 Elementary Schools; and

16 Whereas, "Keep Noblesville Beautiful" acknowledges its
