

HOUSE BILL No. 1525

DIGEST OF INTRODUCED BILL

Citations Affected: IC 20-26.

Synopsis: Biological sexual identity. Provides that student facilities in public school buildings must be designated for use by female students or male students and may be used only by the students of the biological sex for which the facility is designated. Provides that if a school corporation or charter school designates athletic programs as either athletic programs for males or athletic programs for females, a student may participate only in the athletic programs corresponding to the student's biological sex.

Effective: July 1, 2019.

Borders

January 17, 2019, read first time and referred to Committee on Education.

HOUSE BILL No. 1525

A BILL FOR AN ACT to amend the Indiana Code concerning education.

Be it enacted by the General Assembly of the State of Indiana:

1 SECTION 1. IC 20-26-19 IS ADDED TO THE INDIANA CODE
2 AS A **NEW** CHAPTER TO READ AS FOLLOWS [EFFECTIVE
3 JULY 1, 2019]:

4 **Chapter 19. School Facilities**

5 **Sec. 1. This chapter applies to a public school, including a**
6 **charter school.**

7 **Sec. 2. As used in this chapter, "biological sex" refers to the**
8 **physical condition of being male or female, as determined by an**
9 **individual's chromosomes and identified at birth by the**
10 **individual's anatomy.**

11 **Sec. 3. As used in this chapter, "student facility" means a locker**
12 **room, restroom, or shower room that is:**

- 13 (1) **designated for student use; and**
- 14 (2) **accessible by multiple students at the same time.**

15 **Sec. 4. (a) Each student facility within a school building must be**
16 **designated for use by female students or male students.**

17 **(b) A student facility designated solely for:**



1 (1) female students may be used only by students of female
2 biological sex; and

3 (2) male students may be used only by students of male
4 biological sex.

5 **Sec. 5. In any school setting in which a student may be in a state
6 of full or partial undress in the presence of other students, school
7 personnel shall ensure that separate, private areas are provided for
8 use by female students and male students based upon the students'
9 biological sex.**

10 SECTION 2. IC 20-26-20 IS ADDED TO THE INDIANA CODE
11 AS A NEW CHAPTER TO READ AS FOLLOWS [EFFECTIVE
12 JULY 1, 2019]:

13 **Chapter 20. Athletic Programs**

14 **Sec. 1. This chapter applies to a public school, including a
15 charter school.**

16 **Sec. 2. As used in this chapter, "athletic program" refers to an
17 athletic program administered by a school corporation or charter
18 school.**

19 **Sec. 3. As used in this chapter, "biological sex" refers to the
20 physical condition of being male or female, as determined by an
21 individual's chromosomes and identified at birth by the
22 individual's anatomy.**

23 **Sec. 4. If a school corporation or charter school designates
24 athletic programs as either athletic programs for males or athletic
25 programs for females, a student may participate only in the
26 athletic programs corresponding to the student's biological sex.**
