### MR. SPEAKER:

*Your Committee on* Education, to which was referred House Bill 1388, has had the same under consideration and begs leave to report the same back to the House with the recommendation that said bill **be amended** as follows:

- 1 Page 2, line 30, delete "ten" and insert "**five (5)**".
- 2 Page 2, line 31, delete "(10)".
- 3 Page 2, line 38, after "the" insert "**matrix**".
- 4 Page 3, line 18, delete "IC 20-28-11.5-9" and insert "**IC**
- 5 **20-28-11.5-9. The matrix rating system may not grade or compare**
- 6 **teacher preparation programs. The matrix rating system must be**
- 7 **based on data collected for teachers that initially receive their**
- 8 **teaching license during the previous three (3) years."**
- 9 Page 3, line 18, strike "for the three (3) most recent years."
- 10 Page 3, line 19, after "make the" insert "**matrix**".
- 11 Page 3, between lines 20 and 21, begin a new paragraph and insert:
- 12 "**(j) Before July 1, 2015, each teacher preparation program that**
- 13 **is not accredited by the Council for Accreditation of Educator**
- 14 **Preparation shall, except as otherwise provided in this subsection,**
- 15 **require applicants to the teacher preparation program to:**

- 1           **(1) complete a clinical residency program supervised by a**  
 2           **teacher that is rated highly effective by the teacher's**  
 3           **employer;**  
 4           **(2) maintain a grade point average of at least 3.0 on a 4.0**  
 5           **grading scale or its equivalent at the time the individual is**  
 6           **accepted in the teacher preparation program; and**  
 7           **(3) receive a test score that is considered in the top fiftieth**  
 8           **percentile of the SAT or ACT test scores achieved by all**  
 9           **students.**

10          **A teacher preparation program may waive the requirements**  
 11          **described in subdivisions (1) through (3) for not more than ten**  
 12          **percent (10%) of the students admitted to the teacher preparation**  
 13          **program during the same academic year.**

14          **(k) Each teacher preparation program shall report to the**  
 15          **department, in a manner prescribed by the department, the**  
 16          **teacher preparation program's admission practices. The**  
 17          **department shall include information reported to the department**  
 18          **on the department's Internet web site."**

19          Page 3, line 24, delete "and" and insert "**(including a virtual**  
 20          **charter school), eligible school (as defined in IC 20-51-1-4.7), and"**.

21          Page 3, line 34, delete "public".

22          Page 3, line 35, after "school " insert "**described in subsection (a)**".

23          Page 3, line 39, delete "ten (10)" and insert "**five (5)**".

24          Page 3, line 41, delete "charter school or".

25          Page 3, line 42, delete "corporation".

26          Page 4, line 8, delete "public".

27          Page 4, line 8, after "school" insert "**described in subsection (a)**".

28          Page 4, line 9, delete "ten (10)" and insert "**five (5)**".

29          Page 4, line 11, delete "public".

30          Page 4, delete line 14 and insert "**school;**".

31          Page 4, line 23, delete "and".

32          Page 4, line 24, delete "status." and insert "**status; and"**.

33          Page 4, between lines 24 and 25, begin a new line block indented  
 34          and insert:

35                 **"(7) include an assessment by the teacher of the quality of**  
 36                 **instruction of the teacher preparation program in which the**  
 37                 **teacher participated."**

38          Page 4, line 38, delete "corporation and charter school," and insert

- 1       **"described in subsection (a),"**
  - 2           Page 5, line 1, delete "down by:" and insert "**down:**".
  - 3           Page 5, delete lines 2 through 5, begin a new line double block
  - 4       indented and insert:
  - 5           **"(A) by the type of initial teacher license received by**
  - 6           **teachers upon completion of a particular teacher**
  - 7           **preparation program; or**
  - 8           **(B) as otherwise requested by a teacher preparation**
  - 9           **program, as approved by the state board."**
