ENGROSSED SENATE BILL No. 250

A BILL FOR AN ACT concerning family law and juvenile law.

Be it enacted by the General Assembly of the State of Indiana:

- 1 SECTION 1. [EFFECTIVE UPON PASSAGE] (a) **As used in this**
2 **SECTION, "legislative council" refers to the legislative council**
3 **established by IC 2-5-1.1-1.**
4 (b) **As used in this SECTION, "study committee" means either**
5 **of the following:**
6 (1) **A statutory committee established under IC 2-5.**
7 (2) **An interim study committee.**
8 (c) **The legislative council is urged to assign to the appropriate**
9 **study committee the topic of the use of parenting coordinators in**
10 **resolving disputes in custody and parenting matters.**
11 (d) **If the topic described in subsection (c) is assigned to a study**
12 **committee, the study committee shall issue a final report on the**
13 **topic to the legislative council in an electronic format under**
14 **IC 5-14-6 not later than November 1, 2016.**
15 (e) **This SECTION expires December 31, 2016.**
16 SECTION 2. **An emergency is declared for this act.**
