RESOLUTIONS ON FIRST READING

House Concurrent Resolution 37

Representatives Pelath and Dermody introduced House Concurrent Resolution 37:

A CONCURRENT RESOLUTION recognizing Herb Higgins on the occasion of his retirement.

Whereas, Herb Higgins has provided a beacon of hope and a safe place for countless Hoosier children through the Safe Harbor After-School Enrichment Program in Michigan City and LaPorte and Porter counties;

Whereas, Herb Higgins began working with the Safe Harbor program in February 2001;

Whereas, During his time at Safe Harbor, the children have always been Herb's primary concern;

Whereas, The program has continued to provide tutoring and homework assistance and developmental and academic enrichment activities, with a special emphasis on STEM (Science, Technology, Engineering, and Mathematics) education that supports regular school-day instruction;

Whereas, Under Herb's guidance, the number of children served by Safe Harbor has grown from 300 to 550;

Whereas, Early on, Safe Harbor provided programs that included dance, music, art, and languages, but the program now includes before-school programming, STEM, horticulture, community service, and robotics;

Whereas, At the age of 66, Herb feels that now is the right time to open the job up to someone new to try to reach more people using the newest technology;

Whereas, Well known throughout the state, Herb is known as the "dean of after-school" and the "grandfather of after-school" for his many accomplishments in the field;

Whereas, Herb helped to start the Indiana Afterschool Network and is currently on the board;

Whereas, Even before coming to the Safe Harbor program, Herb worked in youth prevention programs;

Whereas, Growing up in Chicago, Herb chose counseling as his life's work because he wanted to help people;

Whereas, Herb views his role as startup director of Interventions, a 175-bed facility in Chicago's Englewood neighborhood where he provided detoxification services for people with substance abuse problems, as one of the major accomplishments of his career;

Whereas, Herb graduated from Northeastern Illinois University with a degree in social services and later earned a master's degree in health science from Governors State University; and

Whereas, Through his work, Herb Higgins has made a difference in the lives of countless children: Therefore,

Be it resolved by the House of Representatives of the General Assembly of the State of Indiana, the Senate concurring:

SECTION 1. That the Indiana General Assembly thanks Herb Higgins for his dedicated service to the children of northern Indiana and wishes him continued happiness and contentment in retirement.

SECTION 2. That the Principal Clerk of the House of Representatives shall transmit a copy of this resolution to Herb Higgins and his family.

The resolution was read a first time and adopted by voice vote. The Clerk was directed to inform the Senate of the passage of the resolution. Senate sponsors: Senators Arnold and Tallian.

House Concurrent Resolution 38

Representatives Richardson, Cook and Saunders introduced House Concurrent Resolution 38:

A CONCURRENT RESOLUTION recognizing December 11, 2016, as the 200th anniversary of Indiana becoming the 19th state in the Union and the 200th anniversary of Abraham Lincoln and his family moving to Indiana.

Whereas, In the winter of 1816, seven-year-old Abraham Lincoln moved from Kentucky with his father, Tom, his mother, Nancy, and his sister, Sarah, to a tiny settlement along Little Pigeon Creek in Spencer County;

Whereas, With an ax in his hands, Abraham experienced the life, culture, and hardships of Indiana pioneer life;

Whereas, On October 5, 1818, he witnessed the death of his beloved mother from milk sickness; she is buried on a gentle knoll between a quarter- and a half-mile from their Indiana home;

Whereas, Abraham went to school in Indiana and was taught "readin', writin', and cipherin'" by Andrew Crawford, James Swaney, and Azel Dorsey;

Whereas, Lincoln was a voracious reader, remarking that "the things I want to know are in books; my best friend is the man who'll git me a book I ain't read";

Whereas, Lincoln's taste in literature was varied; he read the family Bible, borrowed and read "Aesop's Fables", "Pilgrim's Progress", "Robinson Crusoe", Grimshaw's "History of the United States", and Weems's "The Life of George Washington";

Whereas, Abraham Lincoln's education was not limited to school buildings and books;

Whereas, Abraham watched and learned from lawyers, political speakers, and evangelists as they spoke to their audiences and presented their arguments and points of view;

Whereas, While living in Indiana, Lincoln learned many life lessons including that whiskey and tobacco weren't good for the mind or body;

Whereas, Lincoln learned from his stepmother that faith in God should be shown through works more than words;

Whereas, Lincoln's life was struck by tragedy once again when, in 1828, after a year of marriage his sister, Sarah, died in childbirth; the child and Sarah are buried in Indiana;

Whereas, In 1829 Lincoln took a flatboat of goods down the Ohio and Mississippi rivers to New Orleans, where he witnessed his first slave auction, an event that would strongly influence his thoughts on slavery;

Whereas, Abraham Lincoln grew from a young boy to a young man on Hoosier soil, leaving for Illinois in 1830; and

Whereas, Abraham Lincoln's Indiana experiences provided many life lessons that would help prepare him for the office of President of the United States: Therefore,

Be it resolved by the House of Representatives of the General Assembly of the State of Indiana, the Senate concurring:

SECTION 1. That the Indiana General Assembly encourages all citizens of Indiana to take pride in the fact that Indiana is Abraham Lincoln's boyhood home and to celebrate the 200th anniversary of his arrival in Indiana by visiting those sites in Southern Indiana that honor his presence there from 1816 to 1830.

The resolution was read a first time and adopted by voice vote. The Clerk was directed to inform the Senate of the passage of the resolution. Senate sponsor: Senator Kenley.

House Resolution 26

Representatives Behning, Bartlett and Bacon introduced House Resolution 26:

A HOUSE RESOLUTION urging the legislative council to assign to the appropriate study committee the topic of equipping school buses with lap and shoulder safety belts.

Whereas, Millions of children rely on school buses to transport them to and from school safely each day;

Whereas, Seat belts are not currently required in school buses in the state of Indiana;

Whereas, The issue of seat belts on school buses has a long history of debate in Indiana; and

Whereas, To ensure the safety of Hoosier children, it is fitting and proper that further study be done on this issue: Therefore,

Be it resolved by the House of Representatives of the General Assembly of the State of Indiana:

SECTION 1. That the legislative council is urged to assign to the appropriate study committee the topic of equipping school buses with lap and shoulder safety belts.

The resolution was read a first time and referred to the Committee on Education.

House Resolution 27

Representative Miller introduced House Resolution 27:

A HOUSE RESOLUTION recognizing the Elkhart Lions Club's longstanding tradition of service to the Elkhart community.

Whereas, In December 1923, 34 businessmen joined together to establish the Elkhart Lions Club;

Whereas, Members of the Elkhart Lions Club range in age from early 20's to 90 years of age;

Whereas, The Elkhart Lions Club works very hard to help those in need through numerous programs, including the Eyeglass Assistance Program, the Dictionary Project, the KidSight Program, and the SchoolSight Program;

Whereas, The Elkhart Lions Club also presents the "From the Heart" event held each year on Memorial Day weekend so that people can sponsor a flag that is dedicated to a veteran; 200 flags were displayed last year;

Whereas, The Elkhart Lions Club also works to help the Tolson Community and Youth Center to meet some of its financial obligations, and sponsors mission trips to Mexico where the club distributes all the used eye glasses it has collected;

Whereas, The Lions Club also supports the Leader Dog for the Blind facility in Rochester, Michigan, and supports the SchoolSight Program that helps provide vision screenings for school age children; and

Whereas, The people of Elkhart can be duly proud of the contributions made by this worthwhile organization: Therefore,

Be it resolved by the House of Representatives of the General Assembly of the State of Indiana:

SECTION 1. That the Indiana House of Representatives recognizes the good works performed by the Elkhart Lions Club and urges the club to continue serving the needy in the community.

SECTION 2. That the Principal Clerk of the House of Representatives shall transmit a copy of this resolution to the Elkhart Lions Club.

The resolution was read a first time and adopted by voice vote.

Senate Concurrent Resolution 3

The Speaker handed down on its passage Senate Concurrent Resolution 3, sponsored by Representative Bacon:

A CONCURRENT RESOLUTION urging the Indiana Department of Transportation to place a memorial sign where the 38th parallel crosses Interstate 69 just north of Morgan Avenue in Evansville, entitled "Veterans of the Korean War Memorial - 38th Parallel".

The resolution was read a second time and adopted. Roll Call 174: yeas 90, nays 0. The Clerk was directed to inform the Senate of the passage of the resolution.

House Concurrent Resolution 19

The Speaker handed down on its passage House Concurrent Resolution 19, introduced by Representative T. Brown:

A CONCURRENT RESOLUTION urging the Indiana Department of Transportation to rename that part of Interstate 65 from mile marker 138 through mile marker 141, passing through Lebanon, as the "Rick Mount Highway".

The resolution was read a second time and adopted. Roll Call

175: yeas 91, nays 0. The Clerk was directed to inform the Senate of the passage of the resolution. Senate sponsor: Senator Boots.

House Concurrent Resolution 16

The Speaker handed down on its passage House Concurrent Resolution 16, introduced by Representative Morrison:

A CONCURRENT RESOLUTION urging the Indiana Department of Transportation to name the bridge across the Wabash River on State Road 163 in Clinton the "Henry Dana Washburn Memorial Bridge".

The resolution was read a second time and adopted. Roll Call 176: yeas 93, nays 0. The Clerk was directed to inform the Senate of the passage of the resolution. Senate sponsor: Senator Boots

House Concurrent Resolution 15

The Speaker handed down on its passage House Concurrent Resolution 15, introduced by Representative Karickhoff:

A CONCURRENT RESOLUTION urging the Indiana Department of Transportation to rename that portion of U.S. 31 through Howard County as "The Haynes-Apperson Expressway".

The resolution was read a second time and adopted. Roll Call 177: yeas 93, nays 0. The Clerk was directed to inform the Senate of the passage of the resolution. Senate sponsor: Senator Buck.

House Concurrent Resolution 14

The Speaker handed down on its passage House Concurrent Resolution 14, introduced by Representative Goodin:

A CONCURRENT RESOLUTION urging the Indiana Department of Transportation to rename that portion of Interstate 65 from Exit 34 to Exit 50 as "John Mellencamp Way".

The resolution was read a second time and adopted. Roll Call 178: yeas 79, nays 13. The Clerk was directed to inform the Senate of the passage of the resolution. Senate sponsor: Senator Steele.

The House recessed until the fall of the gavel.

The House reconvened at 2:58 p.m. with the Speaker in the Chair.

RESOLUTIONS ON FIRST READING

Senate Concurrent Resolution 35

The Speaker handed down Senate Concurrent Resolution 35, sponsored by Representatives Pierce and Lehman:

A CONCURRENT RESOLUTION honoring Indiana's Bicentennial and celebrating with all Hoosiers the state's 200 years of history.

Whereas, The year 2016 marks 200 years of statehood for the State of Indiana, resulting in bicentennial celebrations spanning the year in recognition of the state's history thus far;

Whereas, On December 11, 1816, President James Madison signed a Congressional Resolution to admit Indiana to the Union as the 19th state, which is now known as Statehood Day;

Whereas, Following admission to the Union, Indiana's rich 200-year history began with Indiana's first constitution being drafted in the state's original capital of Corydon, underneath what has become known as the Constitutional Elm;

Whereas, A second constitutional convention was then held in 1850, resulting in the Indiana Constitution of 1851, which called for more open and frequent elections, put restrictions on state debt, and still governs the state today;

Whereas, In celebration of Indiana's 200-year history, the Indiana Bicentennial Commission has planned events and projects across the state throughout the year to "Celebrate History and Ignite the Future" of Indiana;

Whereas, Notable events and projects include the Bicentennial Plaza, which will create a public space adjacent to Indiana's State House; construction of a new state archives to ensure Indiana's history is properly preserved; the creation of a bicentennial book and medal to commemorate Indiana's statehood; and the promotion of the Bicentennial Nature Trust, which was created to match donations of land and dollars by locals to ensure that land is protected for future Hoosiers to enjoy, among many others; and

Whereas, The bicentennial celebrations will culminate with a 92-county torch relay to promote and unify the state by connecting people, communities, and regions as Hoosiers symbolically pass the torch to ignite future generations to come: Therefore,

*Be it resolved by the Senate
of the General Assembly of the State of Indiana,
the House of Representatives concurring:*

SECTION 1. That the Indiana General Assembly honors Indiana's Bicentennial and celebrates with all Hoosiers the state's 200 years of history.

SECTION 2. The Secretary of the Senate is hereby directed to transmit a copy of this resolution to the members of Indiana's Bicentennial Commission: Lee Hamilton, Becky Skillman and Perry Hammock.

The resolution was read a first time and adopted by voice vote. The Clerk was directed to inform the Senate of the passage of the resolution.

Senate Bill 9

Representative Cook called down Engrossed Senate Bill 9 for second reading. The bill was read a second time by title.

HOUSE MOTION (Amendment 9-2)

Mr. Speaker: I move that Engrossed Senate Bill 9 be amended to read as follows:

Page 1, between the enacting clause and line 1, begin a new paragraph and insert:

"SECTION 1. IC 20-24-2-2, AS ADDED BY P.L.1-2005, SECTION 8, IS AMENDED TO READ AS FOLLOWS [EFFECTIVE JULY 1, 2016]: Sec. 2. (a) A charter school is subject to all federal and state laws and constitutional provisions that prohibit discrimination on the basis of the following:

(1) Disability.

- (2) Race.
- (3) Color.
- (4) Gender.
- (5) National origin.
- (6) Religion.
- (7) Ancestry.
- (8) Sexual orientation.**
- (9) Gender identity.**
- (10) Veteran status.**

(b) It is the public policy of the state to provide all charter school students and employees equal opportunity for education and employment and to eliminate segregation or separation based solely on sexual orientation, gender identity, or veteran status, since such segregation is an impediment to equal opportunity. The practice of denying these rights to such persons is contrary to the principles of freedom and equality of opportunity and shall be considered as discriminatory practices."

Renumber all SECTIONS consecutively.

(Reference is to ESB 9 as printed February 12, 2016.)
