A CONCURRENT RESOLUTION recognizing Virgil L. Beckerman on the occasion his 100th birthday.

Whereas, On April 3, 2020, Virgil L. Beckerman of Princeton, Indiana, will celebrate his 100th birthday;

Whereas, Born in Mt. Carmel, Illinois, Virgil enlisted in the U.S. Army Air Force in 1942, and served as an aircraft instruments technician and mechanic for B-24 bomber planes during World War II as part of the 10th Air Force, 7th Bombardment Group, 9th Bomb Squad, Company 436;

Whereas, Virgil's military service earned him several medals, including the Asiatic-Pacific Medal and the Good Conduct Medal;

Whereas, Virgil returned from duty in 1945 and married his wife, Wilma, on December 25, 1949;

Whereas, For almost 40 years, Virgil worked for the A&P grocery store in Princeton as the head butcher;

Whereas, Virgil is the father of three children, Karen, Kay, and Ken, grandfather to Erin, Jill, Scott, and Shannon, and has numerous nieces and nephews; and

Whereas, Virgil's life and military service has been an inspiration to his family and friends, and he is wished well on this joyous occasion: Therefore,

A HOUSE RESOLUTION celebrating IU Health Bedford Hospital on its 50th anniversary.

Whereas, For the past five decades, Indiana University Health Bedford Hospital has been helping the community, and, in July 2020, they will have been open 50 years;

Whereas, IU Health Bedford Hospital is a critical access hospital that offers inpatient and outpatient care, along with ambulatory care services, an emergency department, and emergency medical services;

Whereas, Approximately 40 IU Health Bedford Hospital team members worked as volunteers on a fitness trail at Hatfield Elementary School in Mitchell, as part of the annual IU Health Day of Service, and also contributed nearly \$15,000, which helped fund the paved walking trail;

Whereas, IU Health Bedford Hospital has a comprehensive diabetes education and care program to help people improve their health on their own, and also have nurses to help patients manage medications, diet, and lifestyle, to improve their lives;

Whereas, Of those who completed the program in 2013, 93 percent were able to reach their goals for monitoring blood glucose, 90 percent met their goals for physical activity, and 75 percent lost weight; and

Whereas, IU Health Bedford Hospital has been helping and healing people for the past 50 years and giving back to the community: Therefore,

Be it resolved by the House of Representatives of the General Assembly of the State of Indiana:

Her husband, Buford, was a molder at Peerless Foundry, but after an explosion at work, he was left blind, and Bernice became his caretaker. He later got a job at the Indiana Blind Agency;

Whereas, Buford died of cancer in 1980 at the age of 80. In their 54 years together, they shared countless memories and traveled far and wide together;

Whereas, Having lived before and after the civil rights movement, the height of which was from 1954 to 1968, she has memories of some unforgettable moments;

Whereas, She has received much recognition for her milestone birthdays, such as turning 100 and 105, but her favorite came from former President Barack Obama and first lady Michelle Obama, who sent her signed letters;

Whereas, When asked the secret to aging, Bernice says to be good, and love everyone;

Whereas, She has a favorite quote from the Bible, "Having therefore obtained help of God I continue unto this day" (Acts 26:22), Bernice has been a devoted member of Bethel African Methodist Episcopal Church for over 70 years and has volunteered in many ministries; and

Whereas, Bernice enjoys spending time with her family, and when her time comes, she wants to be remembered as being a good person, like in the eyes of her nephew, who calls her a saint. She used to visit the elderly and sick from her church, Bethel African Methodist Episcopal Church, and also used to make clothes for people in Africa, because she loves helping people. Therefore,

A CONCURRENT RESOLUTION honoring Eugene Heckman.

Whereas, Eugene Joseph Heckman, 80, passed away Friday, January 24, 2020, at Parkview Regional Medical Center, Fort Wayne;

Whereas, Heckman served as Thorncreek Township Trustee since 1971;

Whereas, Heckman was born on October 30, 1939, in Thorncreek Twp., Whitley County, to Joseph H. and Grace Heckman and graduated from Columbia City High School in 1957 before joining the U.S. Air Force, 122nd Air National Guard Unit;

Whereas, Heckman was deployed to both France and North Africa during the time of the Berlin Wall Crisis, and in November 1963 was honorably discharged;

Whereas, Heckman married Karen Rose VanDeman June 21, 1959, and they called Tri-Lakes their home;

Whereas, In 1971 he bought his father's company, Heckman's Sani-Service, providing solid trash removal, and operated the business until he sold it in 1991;

Whereas, 1971 was the year he was elected Thorncreek Township Trustee, finding his calling in life by serving the people of the community. He was responsible for the operation of the township's public services, including the Thorncreek Twp. School, the Fire Department, cemeteries, and poor assistance, and was key in the Tri-Lake Regional Sewer District;

Whereas, Heckman served on the Whitley County School Board for 24 years;

Whereas, A founding member of the Tri-Lakes Baptist Church, Heckman served as a deacon and superintendent. As a member of Gideons International, he helped distribute Bibles throughout the area. He was a member of the National Solid Waste Association Council for ten years and served as President from 1993 to 1994;

Whereas, His service in government allowed him to meet President George W. Bush, Senator Richard Lugar, Governor Otis Bowen, Vice-President Dan Quayle, and others;

Whereas, Heckman is survived by his wife of 60 years, Karen; three sons, David Heckman, Daniel Heckman, and Bruce Beals; grandchildren, Katrina Straub, Hannah Heckman, Moriah Heckman, Jason Shoemaker, Richard Shoemaker, and Jaime Pepler; nine great-grandchildren; and a brother, Gary Heckman; and

Whereas, Heckman was preceded in death by a sister, Carolyn Boyd, and a great-grandson, Peyton Shoemaker: Therefore,

A CONCURRENT RESOLUTION recognizing the significance of the construction of the Vietnam Memorial Wall at the Veterans National Memorial Shrine and Museum in Fort Wayne, Indiana.

Whereas, On December 30, 2019, the Veterans National Memorial Shrine and Museum in Fort Wayne announced that it will erect a permanent replica of the traveling Washington, D.C., Vietnam Veterans Memorial;

Whereas, The replica monument wall will be part of a new Monument Plaza being constructed, which will include monuments honoring veterans of World War I, World War II, the Korean War, the Iraq War, and Gold Star Families;

Whereas, The Memorial Wall and Monument Plaza are vital parts of the Veterans National Memorial Shrine and Museum mission to remember all veterans and their sacrifices made throughout United States history; and

Whereas, Building a replica of the Vietnam Veterans Memorial in Fort Wayne will help to bring thousands of visitors to the Veterans National Memorial Shrine and Museum to remember all veterans who served in wartime: Therefore,

*Be it resolved by the Senate
of the General Assembly of the State of Indiana,
the House of Representatives concurring:*

SECTION 1. That the Indiana General Assembly recognizes the significance of the construction of the Vietnam Memorial Wall being constructed at the Veterans National Memorial Shrine and Museum in Fort Wayne, Indiana.

SECTION 2. The Secretary of the Senate is hereby directed to transmit a copy of this resolution to the Veterans National Memorial Shrine and Museum

The resolution was read a first time and adopted by voice vote. The Clerk was directed to inform the Senate of the passage of the resolution.

Senate Concurrent Resolution 54

The Speaker handed down Senate Concurrent Resolution 54, sponsored by Speaker Bosma:

A CONCURRENT RESOLUTION fixing the date for the Second Regular Technical Session of the One Hundred Twenty First General Assembly.

Whereas, IC 2-2.1-1-3.5 authorizes the General Assembly to fix a date for the Second Regular Technical Session of the General Assembly;

Whereas, The General Assembly finds that it is in the best interest of the State of Indiana to fix a date for the Technical Session; and

Whereas, It is prudent to allow the President Pro Tempore of the Senate and the Speaker of the House of Representatives to jointly order that the Technical Session not convene if they determine the cost and inconvenience do not justify meeting in Technical Session: Therefore,

Be it resolved by the Senate of the General Assembly of the State of Indiana, the House of Representatives concurring:

SECTION 1. The date for the Second Regular Technical Session of the One Hundred Twenty First General Assembly is hereby fixed for Wednesday, May 13, 2020, at 1:30 p.m.

SECTION 2. The President Pro Tempore of the Senate and the Speaker of the House of Representatives may issue a joint order that the General Assembly not convene in Technical Session if they determine the cost and inconvenience of meeting in Technical Session are not justified
