ENGROSSED HOUSE BILLS ON THIRD READING

Engrossed Senate Bill 2(ss)

Representative T. Brown called down Engrossed Senate Bill 2(ss) for third reading:

A BILL FOR AN ACT to amend the Indiana Code concerning state offices and administration and to make an appropriation.

The bill was read a third time by sections and placed upon its passage. The question was, Shall the bill pass?

Roll Call 62(ss): yeas 93, nays 7. The bill was declared passed. The question was, Shall the title of the bill remain the title of the act? There being no objection, it was so ordered. The Clerk was directed to inform the Senate of the passage of the bill.

HOUSE MOTION

Mr. Speaker: pursuant to Rule 92, I move that further action on Senate Bill 1(ss) be postponed indefinitely.

MOED

Upon request of Representatives Moed and Dvorak, the Speaker ordered the roll of the House to be called. Roll Call 63(ss): yeas 29, nays 70. Motion failed.

Engrossed Senate Bill 1(ss)

Representative McNamara called down Engrossed Senate Bill 1(ss) for third reading:

A BILL FOR AN ACT to amend the Indiana Code concerning health.

The bill was read a third time by sections and placed upon its passage. The question was, Shall the bill pass?

Roll Call 64: yeas 62, nays 38. The bill was declared passed. The question was, Shall the title of the bill remain the title of the act? There being no objection, it was so ordered. The Clerk was directed to inform the Senate of the passage of the bill.

OTHER BUSINESS ON THE SPEAKER'S TABLE

PETITION TO CHANGE VOTING RECORD

Mr. Speaker: Pursuant to House Rule 75, I hereby petition to change my voting record on second reading amendment #63 to House Bill 1001(ss), Roll Call 9, on July 28, 2022. In support of this petition, I submit the following reason:

“I was present and in my seat. I voted NAY on the amendment because I was unclear on an aspect of the amendment, but upon clarification of that aspect, I would like to change my vote to YEA.”
