RESOLUTIONS ON FIRST READING**House Concurrent Resolution 25**

Representatives DeLaney, Bosma, Hale, Mahan, Porter and Bartlett introduced House Concurrent Resolution 25:

A CONCURRENT RESOLUTION congratulating the Bishop Chatard High School Trojans football team on its Class 3A state championship.

Whereas, Bishop Chatard High School of Indianapolis won the Class 3A state football championship on November 27, 2015;

Whereas, The victory was the Trojans' 13th high school football championship in the school's history -- more high school football championships than have been won by any other high school in Indiana;

Whereas, The Trojans attained a 2015 season record of 12-3, scoring 360 points and holding their opponents to 214 points;

Whereas, The Trojans were led by Seniors Patrick Sowinski (6), Nick Grote (8), Lewis Dilts (9), Tommy Grote (10), Pete Saunders (11), Charlie DeSchryver (14), Douglas Hirschfeld (17), Peter Treesh (20), John Chavis (24), Matt Ernst (25), Matthew Adkins (26), Caleb Kobets (27), Brian Goldner (28), Charlie Sexauer (32), Justin Lindsay (33), Max Babcock (34), Chris Wilson (36), Robert Sammy (39), Luke Busald (50), Danny Godlevske (51), Tucker Lewis (56), David Schroeder (62), Collin Noll (64), Jared Penry (66), Mark Webster (74), Kevin-Miguel O'Hara (85), Will Fehribach (86), Jack Gleaves (88), and Jacob Mack (91);

Whereas, Trojan football player Danny Godlevske was chosen as one of the top 50 Football Players in Indiana by the Indiana Football Coaches Association, and players Charlie Sexauer and Pat Sowinski were chosen as Class 3A All-State Players;

Whereas, Ten of the senior players have a 4.0 grade point average;

Whereas, Head Coach Vince Lorenzano, supported by talented and dedicated assistant coaches, has guided seven of his Trojan teams to a state championship title in thirteen years as the Trojans head coach;

Whereas, The Trojans were cared for by committed professional physicians, trainers, and student trainers;

Whereas, The Trojans were enthusiastically supported by the Bishop Chatard student body, faculty and administrators, parents and families, alumni from near and far, and the entire Bishop Chatard community; and

Whereas, An outstanding achievement such as this deserves special recognition: Therefore,

Be it resolved by the House of Representatives of the General Assembly of the State of Indiana, the Senate concurring:

SECTION 1. That the Indiana General Assembly congratulates the Bishop Chatard Trojans on its Class 3A state football championship and wishes the team continued success both on and off the field.

House Concurrent Resolution 26

Representatives Clere, Stemler, Rhoads, Goodin, Davisson, Braun, Arnold and Frye introduced House Concurrent Resolution 26:

A CONCURRENT RESOLUTION congratulating Indiana University Southeast on the occasion of its 75th anniversary.

Whereas, In 1941, Floyd I. McMurray came to southern Indiana to establish an extension center for the Extension Division of Indiana University to meet the growing need for defense and war training as well as to offer additional collegiate courses;

Whereas, In July 1941, the Extension Division of Indiana University selected Jeffersonville as the site, and the Indiana University Board of Trustees gave its formal approval for a new extension center;

Whereas, In 1968, the Indiana University Jeffersonville Extension Center became Indiana University Southeast, and in 1973 the campus was relocated to its present-day location in New Albany;

Whereas, Indiana University Southeast, now one of eight Indiana University campuses, is located on a scenic 180-acre campus less than 15 minutes from downtown Louisville, Kentucky;

Whereas, Indiana University Southeast serves nine Indiana counties and five Kentucky counties, through a tuition reciprocity agreement, houses approximately 400 students in its five residence halls, and has more than 100 student organizations, seven NAA athletic teams, and more than 6,000 enrolled students, and employs nearly 500 faculty members;

Whereas, Since its founding, Indiana University Southeast has grown from an Indiana University extension center to a comprehensive Masters I institution with more than 50 graduate and undergraduate programs;

Whereas, The overall economic impact of Indiana University Southeast on the state of Indiana is \$124.4 million; the total employment impact of Indiana University Southeast in the state of Indiana is 1,476 jobs; Indiana University Southeast generates nearly \$6.5 million per year in state and local tax revenue; and Indiana University Southeast faculty, staff, and students generate more than an estimated \$7.8 million in additional impact through annual charitable donations and volunteer services;

Whereas, Indiana University Southeast faculty produced more than 125 publications, approximately 200 presentations, and 100 performances or exhibits in 2015, including efforts surrounding the internationally recognized Shyness Research Institute, and the Educational Leadership Program, which is the only nationally recognized program of its kind in this region;

Whereas, Indiana University Southeast has been named one of the top universities in Indiana for student-teacher ratio and service to future military members, being ranked 9th and 4th respectively by The College Database;

Whereas, Indiana University Southeast graduated 1,053 students in 2015, of which 37.5 percent were the first in their families to attain an undergraduate degree; and

Whereas, The Indiana University Southeast athletics department is committed to fostering the development of student athletes on the field and in the classroom; more than 50 percent of Indiana University Southeast student athletes have earned a 3.0 grade point average or higher; many student athletes have been named to the Athletic Director's Honor Roll multiple times; and Grenadier teams have earned Indiana University Southeast the Commissioner's Cup as the top athletic department in the Kentucky Intercollegiate Athletic Conference five times in the last seven seasons: Therefore,

Be it resolved by the House of Representatives of the General Assembly of the State of Indiana, the Senate concurring:

SECTION 1. That the Indiana General Assembly congratulates Indiana University Southeast on the occasion of the 75th anniversary of its founding.

SECTION 2. That the Principal Clerk of the House of Representatives transmit a copy of this resolution to Chancellor Ray Wallace.

House Resolution 21

Representatives Bosma, Bartlett, Hale, Riecken and Leonard introduced House Resolution 21:

A HOUSE RESOLUTION honoring the life of Susan Jordan.

Whereas, Susan Jordan dedicated her life to educating and inspiring students, teachers, and parents in the Metropolitan School District of Lawrence Township as a teacher and principal;

Whereas, In keeping with her life of placing her students first, Susan was tragically killed on January 26, 2016, when she bravely sacrificed herself for her students when they found themselves in harm's way;

Whereas, As the principal of Amy Beverland Elementary School, Susan led one of the best and most recognized schools in Central Indiana;

Whereas, Well known in education circles, many have described Susan as a legend in the education field and in her community;

Whereas, Susan Jordan lived her entire life as a hero – full of love and compassion for all;

Whereas, Susan Jordan was a dedicated mother, sister, and educator who devoted herself to her family, friends, and especially her students;

Whereas, Susan Jordan lived by the phrase "A hundred years from now it will not matter what my bank account was, the sort of house I lived in, or the kind of car I drove, but the world may be different because I was important in the life of a child";

Whereas, Faith was paramount in Susan Jordan's life, and she was a longtime dedicated member of St. Luke's United Methodist Church; and

Whereas, Susan Jordan dedicated her life to children and spent the last moments of it protecting those children: Therefore,

Be it resolved by the House of Representatives of the General Assembly of the State of Indiana:

SECTION 1. The Indiana House of Representatives recognizes Susan Jordan for her outstanding leadership in education, her dedication to her students and family, and her final act of heroism, placing herself in harm's way to protect the

lives of her students.

SECTION 2. That the Principal Clerk of the House of Representatives shall transmit a copy of this resolution to the Lawrence Township School Corporation and the family of Susan Jordan.

Whereas, The 2015-2016 Rural Teacher of the Year Award was given to ZoeAnn Chernowsky, a 14-year veteran social studies teacher at Blue River Valley Junior/Senior High School, by the Indiana Small and Rural Schools Association;

Whereas, The person who receives this award represents the many hard-working individuals who have made teaching their life-profession and who have chosen to work in the small and rural schools around the State of Indiana;

Whereas, Chernowsky further serves her school as a teacher-leader, teacher-mentor, the social studies department head, the

girls volleyball coach, and is known for integrating technology and innovative teaching in the classroom;

Whereas, Governor Mike Pence and Indiana Superintendent of Public Instruction Glenda Ritz, also formally congratulated Chernowsky for her accomplishments; and

Whereas, It is fitting that the Indiana General Assembly gives special recognition to Chernowsky for all of the work she has put into Indiana education to be named the 2015-2016 Indiana Rural Teacher of the Year: Therefore,
