## RESOLUTIONS ON FIRST READING

### House Resolution 10

Representatives V. Smith, Summers, Candelaria Reardon, Harris, Porter, Bartlett, C. Brown, Pryor and Shackelford introduced House Resolution 10:

A HOUSE RESOLUTION celebrating Black History Month.

*Whereas, Black history has been celebrated by Americans each year since 1926, first as Negro History Week and later as Black History Month;*

*Whereas, Blacks have been in America since colonial times, but it was not until the 20th century that they were represented in history books;*

*Whereas, The celebration of Black History Month and the study of black history came into being through the efforts of Dr. Carter G. Woodson;*

*Whereas, Dr. Woodson's parents were former slaves, and he spent his childhood working in the Kentucky coal mines;*

*Whereas, Dr. Woodson enrolled in high school at age 20, graduated within two years, and went on to earn a Ph.D. from Harvard University;*

*Whereas, Dr. Woodson was disturbed to find that history books largely ignored the black American population and mentioned blacks only in ways that reflected the inferior social position they were assigned at the time;*

*Whereas, Dr. Woodson began the task of writing black Americans into the nation's history;*

*Whereas, Through the efforts of Dr. Woodson, several organizations were established as a way to bring national attention to the contributions of black people throughout American history, including the Association for the Study of Negro Life and History, founded in 1915 (now known as the Association for the Study of African American Life and History), the Journal of Negro History (now known as the*

*Journal of African American History*), and, in 1926, the establishment of *Negro History Week*;

*Whereas, Dr. Woodson chose the second week of February for Negro History Week because it marks the birthdays of two men who greatly influenced the black American population: Frederick Douglass and Abraham Lincoln;*

*Whereas, Black History Month, celebrated in February, acknowledges the achievements of blacks in the military, arts, civil rights, education, entertainment, history, law, literature, medicine, music, politics, science, sports, and other areas;*

*Whereas, The goal of Black History Month is to bridge the gap created by American history's failure to accurately acknowledge, portray, and record the contributions and inventions of blacks; and*

*Whereas, Black Americans reflect a legacy of courage and dedication that has helped to guide our nation's success and prosperity: Therefore,*

*Be it resolved by the House of Representatives of the General Assembly of the State of Indiana:*

SECTION 1. That the Indiana House of Representatives acknowledges the many contributions and accomplishments of black Americans throughout the history of the United States and Indiana.

SECTION 2. That the Indiana House of Representatives urges entities and organizations to celebrate Black History Month.

The resolution was read a first time and adopted by voice vote.

#### **House Resolution 14**

Representative Koch introduced House Resolution 14:

A HOUSE RESOLUTION urging the legislative council to assign to the appropriate committee the study of the need for, the costs of, the benefits of, and the effects of a wilderness preservation system on state public lands.

*Whereas, The benefits of wilderness areas are numerous, including cleaning our air and filtering our water, providing a home for wildlife, protecting watersheds that provide clean drinking water to surrounding communities, and acting as an economic driver for local communities; and*

*Whereas, In order to ensure that there are wilderness areas for future generations to enjoy, we must study all possible options to protect these wonderful natural resources: Therefore,*

*Be it resolved by the House of Representatives of the General Assembly of the State of Indiana:*

SECTION 1. That the legislative council is urged to assign to the appropriate committee the study of the need for, the costs of, the benefits of, and the effects of a wilderness preservation system on state public lands.

The resolution was read a first time and adopted by voice vote.

#### **House Concurrent Resolution 23**

Representatives Stemler and Soliday introduced House Concurrent Resolution 23:

A CONCURRENT RESOLUTION urging the Indiana Department of Transportation to rename a part of U.S. Highway 31 between Main Street and East Street in the city of Austin as "Berley Goodin Way".

*Whereas, Berley Goodin has dedicated his life to the children of southeastern Indiana and Scott County School District 1;*

*Whereas, Berley Goodin has worked tirelessly to ensure that all children are given the chance to have an outstanding education and become productive citizens of our state and our nation;*

*Whereas, Recognized for his many accomplishments, Berley Goodin has received the Charles F. Maas Distinguished Service Award for District 5 presented by the Indiana Interscholastic Athletic Administrators Association; has been named District 8 Superintendent of the year twice; was named a Kentucky Colonel by the Governor of Kentucky; and was named the Outstanding Alumnus of Austin High School;*

*Whereas, Active outside the schoolroom, Berley Goodin has served as secretary of the Mid Southern Conference for 36 years and is a member of the Scott County Partnership Committee, the Indiana Association of School Business Officials, the Prosser School of Technology Advisory Board, the Southeastern Indiana School Study Council, the Madison Area Special Services Governing Board, the Scott County Chamber of Commerce, the Austin Rural Enterprise Governing Board, Scott County Leadership, the Youth Development Committee, and the Scott County Public Library Board; and*

*Whereas, It is fitting that we recognize the contributions of Berley Goodin to Indiana public education: Therefore,*

*Be it resolved by the House of Representatives of the General Assembly of the State of Indiana, the Senate concurring:*

SECTION 1. That the Indiana General Assembly thanks Mr. Berley Goodin for his years of dedicated service to the children of southeastern Indiana and recognizes his many accomplishments by renaming a part of U.S. Highway 31 between Main Street and East Street in the city of Austin as "Berley Goodin Way".

SECTION 2. That the Principal Clerk of the House of Representatives shall transmit a copy of this resolution to Berley Goodin and his family and the commissioner of the Indiana Department of Transportation.

The resolution was read a first time and referred to the Committee on Roads and Transportation.

#### **House Concurrent Resolution 24**

Representatives Clere, Lehe and Porter introduced House Concurrent Resolution 24:

A CONCURRENT RESOLUTION recognizing the problem of malnutrition and its effect on health outcomes.

*Whereas, A significant percentage of hospital patients are malnourished when entering the hospital;*

*Whereas, Leading health and nutrition experts agree that nutrition status is a direct measure of patient health;*

*Whereas, Good nutrition and good patient health can keep people healthy and out of health care facilities, thereby reducing health care costs;*

*Whereas, Scientific research demonstrates that good nutrition beginning before birth and extending throughout childhood is critical to healthy growth and development;*

*Whereas, Malnutrition is particularly prevalent in vulnerable populations, such as older adults, hospitalized patients, minorities, the poor, and children; and*

*Whereas, Access to nutritious food is critical in restoring and maintaining lean body mass, which improves clinical outcomes, reduces health care costs, and keeps people and their communities healthy: Therefore,*

*Be it resolved by the House of Representatives of the General Assembly of the State of Indiana,*

*the Senate concurring:*

SECTION 1. That the members of the Indiana General Assembly recognize the complex problem of malnutrition and its effect on health outcomes.

SECTION 2. That the Principal Clerk of the House of Representatives shall transmit a copy of this resolution to Governor Mike Pence.

The resolution was read a first time and adopted by voice vote. The Clerk was directed to inform the Senate of the passage of the resolution. Senate sponsors: Senators Pat Miller, Landske and Lanane.

A CONCURRENT RESOLUTION recognizing Dennis Patrick Neary on the occasion of his 70th birthday.

*Whereas, Through his career, civic achievements, and many activities, Dennis Neary has brought credit and distinction to himself and has improved life in the local community and throughout the state;*

*Whereas, The ninth child of Charles Joseph and Loretta Vollrath Neary, Dennis was the first of his 14 siblings to be born in a hospital - Holy Family Hospital in LaPorte - February 11, 1944, and grew up in a three-bedroom, one-bath house on Hawthorne Street;*

*Whereas, Dennis attended Saint Joseph Elementary School and LaPorte High School, obtained a bachelor's degree in history at Murray State in Kentucky, attending on a baseball scholarship, and later acquired a master's of education at Indiana University South Bend;*

*Whereas, Employed since the fourth grade, Dennis has been a Herald Argus newspaper boy, a soda jerk at Theatre Pharmacy, and a Red Shultz gas station attendant during high school, and held college summer jobs including Christmas tree trimmer and weed picker with his sister Kay for Bernacchis' Landscaping, always turning his paychecks over to his father to help support the family;*

*Whereas, Dennis also worked as a laborer for the Indiana State Highway Department and as a full-time and part-time employee for NIPSCO for three years;*

*Whereas, For 23 years, Dennis taught fifth and sixth grade students at Long Beach Elementary School, where he coached every sport offered, including boys' and girls' basketball and track and boys' football and softball, providing rides home after practice and games for children without transportation so they could participate in team sports;*

*Whereas, Active in sports his entire life, Dennis played summer baseball on his father's team, the LaPorte Sportsmen, freshman, junior, and senior baseball as a member of the*

*LaPorte High School Slicers, and safety, running back, and quarterback on the high school football team;*

*Whereas, While in his fifties, Dennis played for the Valley Boyz baseball team in California and has been a season ticket holder for the Colts since 1984;*

*Whereas, Dennis's lifelong dedication to political service began as a child when he and his siblings walked the precincts for his father's campaign;*

*Whereas, In 1968 Dennis served as the LaPorte County chairman for Robert Kennedy's campaign, riding in the backseat of a convertible with Robert and Ethel Kennedy and their dog in a motorcade to the courthouse and joining Rose Fitzgerald Kennedy, Ethel Kennedy, and Eunice Shriver for tea before being asked by the Kennedy campaign to join them in California, an opportunity he declined due to his teaching responsibilities;*

*Whereas, Dennis attended the 1968 Democratic Convention in Chicago, serving as a worker for the Birch Bayh for Vice President Campaign;*

*Whereas, A natural politician, his maternal grandfather was a councilman in Ottawa, Illinois, in the early 1900s, his father was a LaPorte city councilman for 16 years, and Dennis ran for Long Beach Town Council in 1974 but was defeated;*

*Whereas, Dennis was elected to the Indiana Senate in 1976 in an upset victory over the favored and established incumbent;*

*Whereas, Dennis rose through the ranks in the Senate, holding the positions of Assistant Caucus Chairman, Caucus Chairman, and Democratic Floor Leader;*

*Whereas, Dennis was appointed by newly elected Governor Frank O'Bannon as Chairman of the Education and Labor Relations Board and currently works with the legislature as Director of Legislative and Political Affairs with the Indiana Health Care Association, sometimes calling on his former elementary school student, Indiana House Democratic Leader Scott Pelath;*

*Whereas, Dennis maintains friends on both sides of the aisle as a legislator and beyond, marrying a lifelong California Republican who was also raised in a political family with relatives who served in the legislature;*

*Whereas, When daughter Katelyn was born, Dennis asked the doctor, "Is it a Democrat or a Republican?" Startled, the doctor exclaimed, "Neither, it's a girl!";*

*Whereas, Dennis is the proud father of Robert, Ryan, and Abigail with Mary Beth Neary, and Katelyn and Savannah with Suzan Davis Neary, whom he married in the Indiana State House at a wedding officiated by then Lieutenant Governor Frank O'Bannon, Dennis's mentor and close friend;*

*Whereas, Dennis is Grandpa D. to Rory, Molly, Mary Cate, Liam, Ella, and John Ryan Neary;*

*Whereas, Dennis has served on the boards of countless organizations, including the Knights of Columbus, LaPorte Old Timers, Saint Anthony Hospital, Alpha Home, and, most recently, as Vice President of the Minority Health Coalition;*

*Whereas, Active in his community, Dennis gathers donations for numerous charities and entities, including Indianapolis Public School 54, volunteers his time for Second Helpings, and delivers food and items to needy families;*

*Whereas, Through the years Dennis has displayed a weakness for Long's donuts, which he shares with his legislative staff members, interns, state workers, and parking lot attendants;*

*Whereas, Dennis possesses an impressive collection of hats*

*that often evoke a lighter, more playful side of otherwise serious individuals and which have been worn by hundreds of people at conventions, upscale weddings, legislative barn dances, and even a gubernatorial inaugural party where the collection was particularly enjoyed by the newly elected officials' children, volunteers, and party goers; and*

*Whereas, It is appropriate to highlight his many accomplishments and extend to him special honors and the highest commendation: Therefore,*

*Be it resolved by the House of Representatives of the General Assembly of the State of Indiana, the Senate concurring:*

SECTION 1. That the members of the Indiana General Assembly congratulate Dennis Neary on the occasion of his 70th birthday and wish him many more years of happiness and productivity.

SECTION 2. That the Principal Clerk of the House of Representatives shall transmit a copy of this resolution to Dennis Neary and his family.

The resolution was read a first time and adopted by voice vote. The Clerk was directed to inform the Senate of the passage of the resolution. Senate sponsor: Senator Arnold.

### House Concurrent Resolution 26

Representative Messmer introduced House Concurrent Resolution 26:

A CONCURRENT RESOLUTION urging the Indiana Department of Transportation to rename two bridges over U.S. Highway 50 in Daviess County after David Graham and James Newland.

*Whereas, The creation of a highway connecting Evansville to Indianapolis required years of hard work by dedicated people;*

*Whereas, Two of these people are David Graham and James Newland;*

*Whereas, David Graham was born in February 1927 into a southern Indiana family with strong ties to the automobile industry and family farming;*

*Whereas, David Graham spent his working life on his farm and as a banker and political organizer;*

*Whereas, After retiring in his sixties, David Graham became involved in the Southwestern Indiana Regional Highway Coalition (SWIRHC) to build a road connecting Evansville and Indianapolis;*

*Whereas, After a study determined that the project was not economically feasible, David Graham began to look elsewhere for support;*

*Whereas, With the help of John D. Caruthers of Shreveport, Louisiana, the Mid-Continent Highway Coalition came to be;*

*Whereas, At the time of the creation of the Mid-Continent Highway Coalition, James Newland was running the SWIRHC;*

*Whereas, David Graham recruited James Newland to join the Mid-Continent Highway Coalition where he worked tirelessly for more than a decade advocating, both in Indiana and on a national scale, for the highway; and*

*Whereas, These two dedicated Hoosiers worked tirelessly for many years trying to improve the lives of Hoosiers by creating a safer, quicker route to Indianapolis: Therefore,*

*Be it resolved by the House of Representatives of the General Assembly of the State of Indiana, the Senate concurring:*

SECTION 1. That the Indiana General Assembly recognizes the dedication of David Graham and James Newland in securing a highway connecting Evansville to Indianapolis by urging the Indiana Department of Transportation to rename two bridges over U.S. Highway 50 in Daviess County east of Washington (I69-14-09515 SB and I69-14-09525 NB) after David Graham and James Newland.

SECTION 2. That the Principal Clerk of the House of Representatives shall transmit a copy of this resolution to the families of David Graham and James Newland.

The resolution was read a first time and referred to the Committee on Roads and Transportation.

### Senate Concurrent Resolution 4

The Speaker handed down Senate Concurrent Resolution 4, sponsored by Representative Bacon:

A CONCURRENT RESOLUTION commending the Indiana Department of Transportation on the management practices of the innovative Hoosier Roadside Heritage Program.

*Whereas, The roadside vegetation management practices of Indiana and the federal government aim to secure motorist safety, reduce the presence of noxious weeds, and stabilize the soil to complement good soil and water conservation practices;*

*Whereas, State and local highway departments are facing severe budget shortfalls;*

*Whereas, Native forbs and grasses are less likely to encroach onto roads than invasive species such as kudzu;*

*Whereas, Native forbs and grasses are best adapted to local conditions and thus require less active management, reducing the need to replant, weed, and mow the areas adjacent to the road;*

*Whereas, Integrated vegetation management practices reduce the cost of maintaining roadside vegetation, with the Hoosier Roadside Heritage program saving Indiana \$45 per acre a year in maintenance costs;*

*Whereas, Pollinators such as bees, birds, bats, and butterflies are suffering drastic population loss, due in part to habitat loss;*

*Whereas, Pollinators are vital to American agriculture and are responsible for one out of every three bites of food we eat;*

*Whereas, A diverse pollinator population is necessary to maintain the diversity of our plant life and food supply;*

*Whereas, Enhancing pollinator populations on rights-of-way can result in improved pollination for neighboring lands, including agriculture and wildlife ecosystems;*

*Whereas, Sound wildlife ecosystems help support Indiana's \$1.7 billion a year outdoor recreation industry; and*

*Whereas, Highway rights-of-way that are kept in a native state sequester carbon in the soil, and reduced mowing lowers greenhouse gasses, both of which help to prevent climate change: Therefore,*

*Be it resolved by the Senate of the General Assembly of the State of Indiana, the House of Representatives concurring:*

SECTION 1. That the Indiana General Assembly commends the Indiana Department of Transportation for its innovative Hoosier Roadside Heritage Program, which saves taxpayer dollars, improves the environment, and supports agriculture production.

SECTION 2. That the Indiana General Assembly further encourages the Indiana Department of Transportation to work with local governments and conservation groups to promote Hoosier Roadside Heritage Program maintenance practices

throughout Indiana.

SECTION 3. That copies of this resolution be transmitted by the Secretary of the Senate to the Indiana Department of Transportation.

The resolution was read a first time and referred to the Committee on Roads and Transportation.

### Senate Concurrent Resolution 5

The Speaker handed down Senate Concurrent Resolution 5, sponsored by Representatives Heuer and GiaQuinta:

A CONCURRENT RESOLUTION congratulating Keefer Printing Company, Inc., on the occasion of the 100th anniversary of its founding.

*Whereas, In January 1914, James Keefer moved his family to Fort Wayne from Ossian, where he had served as publisher of the Ossian News since 1889;*

*Whereas, In Fort Wayne James Keefer opened a small printing company at 921 Broadway that would be known as the Keefer Printing Company, Inc.;*

*Whereas, Under the guidance of James and his four sons, Keefer Printing began by specializing in stationery, posters, tickets, and other printing jobs;*

*Whereas, The company's reputation for excellence grew and, in the 1940s and 1950s, Keefer Printing became widely known for printing in-house newspapers for several of the largest companies in the area, including General Electric and International Harvester, along with many other publications, including yearbooks for some local high schools and game programs for the Fort Wayne Komet Hockey Club, a job it still performs today;*

*Whereas, With the installation of new offset presses in the 1960s, the company began to concentrate on printing color brochures and catalogs for many of Fort Wayne's leading businesses and organizations; and*

*Whereas, For five generations the Keefer family has maintained its commitment to serving a wide range of businesses and charitable organizations in the Fort Wayne community: Therefore,*

*Be it resolved by the Senate  
of the General Assembly of the State of Indiana,  
the House of Representatives concurring:*

SECTION 1. That the Indiana General Assembly congratulates Keefer Printing Company, Inc., on the occasion of the 100th anniversary of its founding and recognizes the many contributions Keefer Printing Company, Inc., has made to the community and Indiana.

SECTION 2. That copies of this resolution be transmitted by the Secretary of the Senate to president and owner Richard Keefer and the Keefer family.

The resolution was read a first time and adopted by voice vote. The Clerk was directed to inform the Senate of the passage of the resolution.

### Senate Concurrent Resolution 9

The Speaker handed down Senate Concurrent Resolution 9, sponsored by Representative Speedy:

A CONCURRENT RESOLUTION recognizing the value of a Presidential Youth Council.

*Whereas, Our nation faces serious challenges in the near future that could significantly impact the lives of young Americans for decades to come;*

*Whereas, The majority of 18- to 29-year-old Americans (71%) do not believe they have a voice in their government;*

*Whereas, The unique perspectives and insights of these young people are vital to the future success of our nation;*

*Whereas, The Millennial Generation is the generation that is most likely to be involved in service to their communities but the least likely to be civically engaged;*

*Whereas, Bridging this gap in interest is a necessity;*

*Whereas, A Presidential Youth Council could help young Americans believe their voices are being heard;*

*Whereas, A Presidential Youth Council could provide the 104 million Americans under the age of 24 a substantive say in governmental policies that affect them;*

*Whereas, This council, representing the diversity of Americans, could serve as a sounding board for federal agencies' youth-related initiatives making the federal government more efficient and effective; and*

*Whereas, Governors, state legislatures, mayors, and city councils have created youth councils that have proven to be an effective means of garnering input from young people, leading to more effective and efficient policies: Therefore,*

*Be it resolved by the Senate  
of the General Assembly of the State of Indiana,  
the House of Representatives concurring:*

SECTION 1. That the Indiana General Assembly urges the establishment of a Presidential Youth Council to advise the President and the administration on the perspectives of young people, to make public policy-related youth programs more efficient and effective, and to address issues that will affect the long-term future of the United States.

SECTION 2. That copies of this resolution be transmitted by the Secretary of the Senate to the members of the Indiana Congressional delegation.

The resolution was read a first time and adopted by voice vote. The Clerk was directed to inform the Senate of the passage of the resolution.

## ENGROSSED HOUSE BILLS ON THIRD READING

### Engrossed House Bill 1002

Representative T. Brown called down Engrossed House Bill 1002 for third reading:
